**TITLE:** Awarding a Nineteen (19) Month Contract (ending 4/30/27) with Three (3) Twelve (12) month options to extend which will match the existing contracts terms for the furnishing of Ice Machine Rental Services for use by Various County Departments to Easy Ice, of Lenexa, KS under the terms & conditions of the 16<sup>th</sup> Judicial Circuit of Missouri (C.C. of J.C.) bid no. 10002261, and existing competitively contract.

**SUMMARY:** The Purchasing Department requires a contract for the furnishing of Ice Machine Rental Services to cover preventive maintenance, winterization and any "as needed" cleaning, service or equipment repairs. The Courts award Letter, Easy Ice contract amendment allowing Jackson County, MO access, and Department Deposition Memos with their estimated spend are attached. Pursuant to Section **1030.4** of the Jackson County Code, the Director of Finance and Purchasing recommends the award for a Nineteen (19) Month Contract with Three (3) Twelve (12) month options to extend for the furnishing of Ice Machine Rental Services to cover preventive maintenance, winterization and any "as needed" cleaning, service or equipment repairs for use by Various County Department to Easy Ice, of Lenexa, KS under the terms & conditions of the 16<sup>th</sup> Judicial Circuit of Missouri (C.C. of J.C.) bid no. 10002261, and existing competitively contract. This award is made on an "As Needed" basis and does not obligate Jackson County, Missouri to pay any specific amount. The annual estimated spend for this contract is \$35,500.00. The availability of funds for specific projects is subject to annual appropriations. The Jackson County Compliance portal was checked and the recommended

vendor has a Status of "Certificate Issued and Emailed to Vendor".
