RESOLUTION NO. 18242, August 19, 2013

INTRODUCED BY Dan Tarwater, County Legislator

WHEREAS, by Resolution 18105, dated February 25, 2013, the Legislature did authorize the allocation of one-half of the budgeted Anti-Drug Sales Tax funds for the Sheriff's Office's 2013 Drug Abuse Resistance Education (DARE) program, and;

WHEREAS, the COMBAT Administration now recommends that the remaining balance of \$50,015.00 in the Sheriff's Office's Anti-Drug Sales Tax Fund be transferred to its 2013 DARE program; and,

WHEREAS, the County Executive has recommended said transfer; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the following transfer be made within the 2013 Anti-Drug Sales Tax Fund:
