5 COMMUNICATIONS AND REPORTS OF THE COUNTY EXECUTIVE

Katheryn Shields, County Executive, reported that last Monday evening, Bishop Boland of the Catholic Diocese of Greater Kansas City-St. Joseph celebrated a mass at the Detention Center. There were 38 inmates, nine volunteers and Fr. Ernie Gauthier, assistant Chaplain, in attendance. She thanked the Detention Center volunteers, Fr. Gauthier and Bishop Boland for this special event. She said the last time a Catholic Bishop celebrated Mass at the Jackson County Detention Center was more than 15 years ago.

Secondly, she announced that the Administration is getting ready to launch a special project with many County employees. She initiated a process designed to obtain the input of County employees in reviewing the County's core functions and answering two questions:

"How can we do the business of Jackson County better?"
"What tools do employees need to help them create a
more efficient and effective operation for taxpayers?"

The goal is to identify innovative policies and procedures. More than 60 employees will be invited to participate in a 1 1/2 day meeting to create a "future vision" for Jackson County and a blueprint for getting there. The County Executive said she is excited about this project and appreciates the employees who will participate.

Katheryn Shields said in the add-on packet is Resolution #12436, transferring money to cover the cost of a study of health issues in the city of Sugar Creek. The cost of the study will be approximately \$30,000.00 which is for research only. There will be no payment for the two physicians who will be leading the study.

Fred Arbanas, County Legislator, reported that many organizations volunteer to help collect money at Christmas in the Park and are given a portion of the money collected on the evening their organization volunteers. However, one organization, Don Bosco, will not participate which leaves an opening. He asked the County Executive to pick two names of other organizations from a container. The first organization will be approached to take Don Bosco's spot. If they decline, the second organization will have the opportunity to participate.

The first organization picked was Safety and Health Council of Western, Missouri. The second organization picked was St. Paul's Presbyterian Church.
