5 COMMUNICATIONS AND REPORTS OF THE COUNTY EXECUTIVE

Dennis Waits, Chairman, presented a 25 year service pin to Floyd Carter, Corrections Shift Administrator.

Dan Tarwater, County Legislator, presented a 30 year service pin to James McCoy, Manager of Detention.

Dan Tarwater presented a 30 year service pin to Jon Barth, Human Resource Administrator for Corrections.

Katheryn Shields, County Executive, suggested a pause for a moment and give thanks because Jackson County was not part of the very bad storms that occurred yesterday. Clay, Platte and Wyandotte counties were not so lucky and we stand ready to help in any way possible.

She gave a circuit breaker report. She mentioned that it provides eligible seniors with an income tax refund up to \$750, based on annual income and the amount of property tax they pay. This tax break has been available for years, but not enough seniors are taking advantage of it.

Ms. Shields went over a plan to better inform Jackson County seniors of this circuit breaker that is available to them. Details of the campaign could include: an insert with all tax bills mailed in the fall; a separate direct mail piece sent only to households with an individual over the age of 65; TV and radio public service announcements (PSA's) to be produced and placed in the fall; a speakers bureau that would take the message to various groups of seniors beginning in the fall; training county employees to assist seniors with filling out the form, and publicize their availability for this purpose; forming a task force of volunteers, perhaps through AARP, to send to retirement centers and senior centers.

Bob Spence, County Legislator, asked if the circuit breaker applied only to senior citizens or also to those with social security and disability.

Ms. Shields replied that it applies only to senior citizens age 65 and older.

Fred Arbanas, County Legislator, asked if the income figure had been adjusted over the years.

Ms. Shields said she did not think it had been adjusted and suggested that we consider lobbying for an increase in that amount in Jefferson City next year.

Katheryn Shields reminded everyone that another tax break Jackson County currently provides to seniors is the option of paying their property taxes by installment. Currently almost 6,200 seniors are taking advantage of this benefit. The first half is due on December 31 and the second half is due on February 28. If married, seniors are still eligible even if only one spouse is age 62 or over.

Jackson County sponsored a school challenge to see who could recycle the most material and the first prize winner was Glendale Elementary in Independence, Missouri. Prizes will be given at the school on Wednesday, May 7, 2003 at 10:30 p.m.

A welcoming reception is being held today immediately following the legislative meeting for the new Jackson County officials.

Dennis Waits said if there was no objection, Ronald E. Finley's vote on Resolution #14572 would be changed from "No" to "Yes" per Mr. Finley's request. No objection was noted.
