The Point Blank Model AXB111A Ballistic Vest has been recommended by the Deputies and the Upper Command Officers of the Sheriff's Office. The Kansas City, Missouri Police Department has a current Term and Supply Contract with Galls, Inc.</p> <p>Pursuant to Section 1030.4 of the Jackson County Code, the Sheriff's Office and the Purchasing Department request the approval of a Term and Supply Contract for Ballistic Vests with Galls, Inc. of Lexington, Kentucky under the terms and conditions of Kansas City, Missouri Police Department Contract No. 2020-2, a competitively bid government contract. The quantity of Ballistic Vests purchased by the Kansas City, Missouri Police Department provides for better pricing on this contract. **SUBJECT: Request to purchase ballistic vests from Galls utilizing an existing government contract**

Ms. Casamento,

I am submitting this memorandum to request for consideration to purchase ballistic vests utilizing an existing contract between Galls and the City of Kansas City, Missouri.

After review by the Sheriff's Office Supply Unit, and with approval of upper command, the Sheriff's Office requests permission to purchase the Point Blank ballistic vest, Model AXBIII A under garment vest in male and female custom cut with two internal carriers and one soft 5x8 trauma plate. I have attached a copy of the current contract with the City of Kansas City, Missouri authorizing the Kansas City Missouri Police Department to purchase this particular vest from Galls. The initial contract period is from April 1, 2020 through March 30, 2021 with the option for four renewals.

In conclusion, the Sheriff's office has been without a vest provider for several months due to the previous supplier closing their business. After careful consideration Galls LLC was selected as the best option by our Supply Unit and members of the Fraternal Order of Police, the Sheriff's Office sworn members bargaining unit. The Sheriff's Office currently rotates vests every five years, per manufacturer recommendation, and we estimate an annual cost of \$20,250.00. The Sheriff's Office requests permission to make Galls a term and supply vendor for five months, with a twelve month extension to run current with the Kansas City Missouri contract. Thank you for your consideration.
