TITLE: AN ORDINANCE requiring the Jackson County Assessor postpone any reclassification of Short Term Rental properties from Residential to Commercial until a full registration and reporting system can be established County-wide

SUMMARY: WHEREAS Jackson County and the greater Kansas City region will be hosting the World Cup in 2026; and, WHEREAS, the KC2026 Committee has estimated that the region may host over 650,000 travelers but only has 65,000 hotel rooms within a 100 mile radius; and, WHEREAS, Jackson County needs to have policies which encourage more housing availability for this important event; and, WHEREAS, the Assessor has expressed an intent to modify the categorization of certain Residential properties which may be identified as Short Term Rentals; and, WHEREAS, the statutory and judicial authority cited by the Assessor for the modification of the classification of Short Term Rentals is based upon RSMO 137.016 (last revised in 2018) and Shipman v. Dominion Hospitality 148 S.W. 3d 821 (a 2004 decision by the Supreme Court); and, WHEREAS, the policy change for classification of Short Term Rentals as Commercial is based upon
