THIRD ADDENDUM TO AGREEMENT

THIS THIRD ADDENDUM TO AGREEMENT, by and between **JACKSON COUNTY, MISSOURI**, hereinafter referred to as "the County," and **NEIGHBORHOOD HOUSING (49/63)**, 5835 Troost, Kansas City, MO 64110, a Missouri not-for-profit corporation, hereinafter referred to as "**Organization**," is made and entered into this 22nd day of November, 2011.

WITNESSETH:

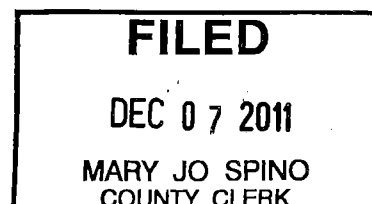
WHEREAS, by Resolution 17140, dated January 19, 2010, the County and Organization did enter into an agreement whereby Organization agreed to provide drug prevention services, at a cost to the County of \$22,000.00; and,

WHEREAS, by Resolution 17470, dated January 18, 2011, the County Legislature authorized the County Executive to enter into the First Addendum to Agreement and by Resolution 17564, dated April 11, 2011, the Legislature authorized a Second Addendum to Agreement; and,

WHEREAS, the Jackson County Drug Commission has recommended an additional extension to the agreement for drug prevention services, at an additional cost to the County in the amount of \$7,150.00; and,

WHEREAS, by Resolution 17730, dated November 7, 2011, the County Legislature has authorized the County Executive to enter into this Third Addendum to Agreement;

NOW THEREFORE, in consideration of the mutual covenants and promises herein contained, County and Organization do hereby additionally agree as follow:




1. Except as hereinafter specifically modified, all of the terms of the prior Agreement between the parties dated February 25, 2010, shall remain in full force and effect and the terms and conditions thereof are incorporated herein by reference.

3. This Addendum to Agreement shall be effective as of September 1, 2011 and shall extend, with the original Agreement, through December 31, 2011.


