FIRST ADDENDUM TO COOPERATIVE AGREEMENT


WITNESSETH:

WHEREAS, the execution of this addendum is authorized by Resolution 18222, dated July 22, 2013;

- 1. Except as expressly provided herein, all provisions of the Cooperative Agreement between Agency and County, dated February 6, 2013, shall remain in full force and effect.
- 2. The Cooperative Agreement of February 6, 2013, is amended by the substitution of Exhibit A attached hereto, for Section C: 2013 Program Budget page in the Exhibit A attached to the Cooperative Agreement.
- 3. This First Addendum to the Agreement, together with the Cooperative Agreement, dated February 6, 2013, shall be effective January 1, 2013 and shall extend until December 31, 2013.
- 4. This First Addendum to Agreement, together with the Cooperative Agreement dated February 6, 2013, incorporates the entire understanding and agreement of the parties.
