

**FIRST ADDENDUM TO
COOPERATIVE AGREEMENT**

THIS FIRST ADDENDUM made this 25 day of July, 2013, by and between **JACKSON COUNTY, MISSOURI**, hereinafter called "County" and **MATTIE RHODES CENTER**, 1740 Jefferson, Kansas City, Missouri 64108, hereinafter called "Agency."

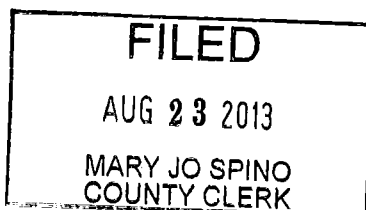
WITNESSETH:

WHEREAS, Agency and County entered into a Cooperative Agreement dated February 6, 2013, whereunder Agency agreed to provide the Youth Violence Prevention Project, as authorized by Resolution 18053, dated January 7, 2013, at a cost to the County not to exceed \$25,000.00; and,

WHEREAS, it is necessary to revise the original budget presented by Agency by reallocating \$4,000.00 from contractual services to personal services, as is more fully described in the Section C: 2013 Revised Program Budget page attached hereto as Exhibit A and incorporated herein by reference; and,


WHEREAS, the execution of this addendum is authorized by Resolution 18222, dated July 22, 2013;

NOW, THEREFORE, in consideration of the foregoing and the terms and provisions herein contained, County and Agency respectively agree with each other as follows:




1. Except as expressly provided herein, all provisions of the Cooperative Agreement between Agency and County, dated February 6, 2013, shall remain in full force and effect.
2. The Cooperative Agreement of February 6, 2013, is amended by the substitution of Exhibit A attached hereto, for Section C: 2013 Program Budget page in the Exhibit A attached to the Cooperative Agreement.
3. This First Addendum to the Agreement, together with the Cooperative Agreement, dated February 6, 2013, shall be effective January 1, 2013 and shall extend until December 31, 2013.
4. This First Addendum to Agreement, together with the Cooperative Agreement dated February 6, 2013, incorporates the entire understanding and agreement of the parties.
