LSaaS Renewal Options:

1. Customer may renew the LSaaS Agreement at the end of Year 5 at the same rate and receive a new LiveScan unit consisting of a new optical scanner, PC, camera, and monitor. Any peripheral equipment such as a camera, printer and cabinet would be optional on renewal. Or, *
2. Purchase the existing LiveScan unit outright for \$3,200.00 at the end of Year 5 and optionally enter into a maintenance agreement at the current maintenance rates at the time of “buy out”; maintenance options for 9x5 and 24x7. Or,
3. Let the Agreement expire at the end of Year 5; IDEMIA will remove the existing LiveScan unit.

***LSaaS “Gap Maintenance” covers replacement parts for any component of a Livescan device (PC, Software, optical block, printer, and camera) until such time new equipment is installed and is covered under a new LSaaS contract agreement due to a supply shortage or some other unforeseen circumstances.**

State Agency and Local Law Enforcement LiveScan Equipment Pricing:

New Equipment Maintenance, Initial One-Year Period after Expiration of Warranty: See Equipment Pricing Tables for initial one-year maintenance pricing to take effect after expiration of one-year warranty. Monthly maintenance pricing is calculated by taking annual maintenance and dividing by 12.

Maintenance Renewal Pricing: Upon the anniversary date of the equipment acquisition, equipment maintenance pricing may be increased by no more than 3% of the previous year’s maintenance price.
