AN ORDINANCE repealing Schedule I to Chapter 31, <u>Jackson County</u> <u>Code</u>, 1984, relating to sewer fees and charges and enacting, in lieu thereof, one new schedule relating to the same subject.

ORDINANCE NO. 5587, January 3, 2022

INTRODUCED BY Jalen Anderson, County Legislator

WHEREAS, the Environmental Health Administrator has recommended that the County's schedule of sewer fees and charges for the residents of certain sewer districts be adjusted to cover increased costs of providing services and to impose fees for new improvements needed at sewer treatment plants; and,

WHEREAS, the current sewer rates in these districts have been in effect for at least twenty-four years and have fallen well behind the costs of providing these services; and,

WHEREAS, said adjustments, as reflected in the attached Schedule I, are in the best interests of the citizens of the County; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, as follows:

Section A. <u>Enacting Clause</u>. Schedule I, Chapter 31, <u>Jackson County Code</u>, 1984, is hereby repealed and one new schedule enacted in lieu thereof, to be known as Schedule I, to read as indicated on the attachment.

Effective Date: This Ordinance shall be effective immediately upon its signature by the County Executive.

Project/Title:

Establishing new monthly sewer rates of \$105 a month for the users of the Carriage Oaks wastewater treatment plant and \$70 per household per month for the Trophy Estates subdivision to meet current regulatory and operating requirements effective February 1, 2022.

Request Summary

The County has not adjusted monthly sewer rates for the sewer treatment plants that it operates on behalf of residents of the Carriage Oaks Neighborhood Association and the Trophy Estates subdivision in unincorporated Jackson County. These aging wastewater treatment plants are in need of equipment repairs and are incurring additional operating expenses to meet current regulatory standards of the Missouri Department of Natural Resources. County staff have had several conversations with representatives of the neighborhoods and have reached general consensus on a rate for 2022. Current rates are \$42 per month increasing to \$105 per month for Carriage Oaks. Current rates are \$23 per month increasing to \$70 per month for residents of Trophy Estates. County staff will continue to meet with residents as long-term operating plans and budgets are developed or alternative service providers idenfitied.
