## IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

**AN ORDINANCE** repealing section 1810., <u>Jackson County Code</u>, 1984, relating to County Municipal Court fees and costs, and enacting, in lieu thereof, one new section relating to the same subject.

ORDINANCE NO. 5625, June 6, 2022

**INTRODUCED BY** Ronald E. Finley, County Legislator

WHEREAS, Missouri law requires the County to collect a \$7.00 fee on cases in County

Municipal Court, with limited exceptions, to be used to fund statewide court automation;

and,

WHEREAS, it is appropriate that the Jackson County Code be revised to provide for this fee; now therefore,

BE IT ORDAINED by the Legislature of Jackson County, Missouri, as follows:

Section A. Enacting Clause

Sections 1810., <u>Jackson County Code</u>, 1984, is hereby repealed, and one new section enacted in lieu thereof, to be known as section 1810., to read as follows:

#### 1810. Court Costs.

#### 1810.1 <u>Generally</u>.

Costs and procedures in the County Municipal Court shall be governed by the provisions of law relating to municipal ordinance violations in municipal divisions of circuit courts.

#### 1810.2 <u>Specific Costs</u>.

Specific items of court costs are as follows:

#### a. <u>Clerk Fee</u>.

A fee of twelve dollars (\$12.00) shall be levied for each ordinance violation filed before a county municipal judge and in the event that a defendant pleads guilty or is found guilty, the judge may assess costs against the defendant. Except as otherwise provided, the costs of this subsection are in lieu of other court costs. The costs herein provided shall be collected by the authorized clerk and deposited into the county treasury. Section 488.012.3(6), RSMo.

## b. <u>County Fee</u>.

A fee of ten dollars (\$10.00) shall be assessed for violation of a county ordinance, except that no such fee shall be collected when the proceeding or defendant has been dismissed by the court or when costs are to be paid

by the county. All such fees shall be payable to the county treasurer, who shall deposit those funds in the county treasury. Section 488.4014.1, RSMo.

#### c. <u>Court Automation Fund Fee</u>.

A fee of seven dollars (\$7.00) for the statewide court automation fund shall be assessed as costs and disbursed as provided by section 488.027.2, RSMo, for violations of any county ordinance, except that no such fee shall be collected in any proceeding involving a violation of an ordinance when the proceeding or defendant has ben dismissed by the court or when costs are waived or are to be paid by the county. Sections 488.012.3(5) and 488.027.2, RSMo.

#### [c] d. Crime Victims' Compensation (CVC) Fund Surcharge.

A surcharge of seven dollars and fifty cents (\$7.50) for the "Crime Victims' Compensation Fund" shall be assessed as costs and distributed in the manner provided in section 595.045, RSMo, for violation of any county ordinance, except that no surcharge shall be collected when the proceeding or defendant has been dismissed by the court or when costs are to be paid by the county. Sections 488.5339.1 and 595.045, RSMo.

#### [d] e. Brain Injury Fund Surcharge.

A surcharge in the amount of two dollars (\$2.00) shall be assessed as costs for the violation of a county ordinance, which surcharge, when collected, shall be paid into the state treasury to the credit of the brain injury fund

created by section 304.028.1, RSMo. No such surcharge shall be collected when the court has dismissed the charge against the defendant, or when the costs are to be paid by the county. Section 304.028, RSMo.

#### [e] f. Independent Living Center Fund Surcharge.

A surcharge of one dollar (\$1.00) shall be assessed for violation of a county ordinance, except that no such surcharge shall be assessed when the proceeding or defendant has been dismissed by the court or when costs are to be paid by the county. Such surcharge shall be collected by the clerk of the court and paid to the credit of the independent living center fund established by section 178.653. RSMo. Section 488.5332, RSMo.

#### [f] g. Motorcycle Safety Trust Fund Surcharge.

A surcharge in the amount of one dollar (\$1.00) shall be assessed as costs for the violation of a county ordinance, which surcharge, when collected, shall be paid into the state treasury to the credit of the motorcycle safety trust fund created by section 302.137.1, RSMo. No such surcharge shall be collected when the court has dismissed the charge against the defendant, or when the costs are to be paid by the county. Section 302.137, RSMo. [g] <u>h</u>. <u>Peace Officer Standards and Training (POST) Commission</u> <u>Surcharge</u>.

A surcharge of one dollar (\$1.00) shall be assessed for the violation of a county ordinance. No such surcharge shall be assessed when the proceeding or defendant has been dismissed by the court or when costs are to be paid by the county. The surcharges collected pursuant to this subsection shall be transmitted to the State Treasury to the credit of the peace officer standards and training commission fund created in section 590.178, RSMo. Section 488.5336.1, RSMo.

## [h] <u>i</u>. <u>Prosecuting Attorneys and Circuit Attorneys' Retirement Fund</u> <u>Surcharge</u>.

A surcharge in the amount of four dollars (\$4.00) shall be assessed as costs for the violation of a county ordinance, which surcharge, according to section 56.807 RSMo, shall be utilized by the county treasurer for payments required to be made pursuant to section 56.807, RSMo for the Missouri Prosecuting Attorneys and Circuit Attorneys Retirement Fund. No such surcharge shall be collected when the court has dismissed the charge against the defendant, when the costs have been waived or are to be paid by the county. Sections 488.026 and 56.807.7, RSMo.

#### [i] j. Prosecuting Attorney Training Fund Surcharge.

A surcharge of five dollars (\$5.00) shall be assessed for violation of a county ordinance, except that no such surcharge shall be collected when the proceeding or defendant has been dismissed by the court or when costs are to be paid by the county. Half of all moneys collected pursuant to this subsection shall be payable to the state treasurer for deposit to the credit of the "Missouri Office of Prosecution Services Fund" created by section 56.765.2, RSMo. Half of all moneys collected shall be payable to the county treasurer who shall deposit all of such funds into the county treasury in a separate fund to be used solely for the purpose of additional training for prosecuting attorneys and their staffs in accordance with the requirements of section 56.765.3, RSMo. Sections 488.5017 and 56.765, RSMo.

#### [j] <u>k</u>. <u>Spinal Cord Injury Fund Surcharge</u>.

A surcharge in the amount of two dollars (\$2.00) shall be assessed for the violation of a county ordinance, which surcharge, when collected, shall be paid into the state treasury to the credit of the spinal cord injury fund created in section 304.027, RSMo. No such surcharge shall be collected when the court has dismissed the charge against the defendant, or when the costs are to be paid by the county. Section 304.027, RSMo.

#### [k] <u>I. Juvenile Justice Preservation Fund Surcharge</u>.

A surcharge in the amount of two dollars (\$2.00) shall be assessed as costs for the violation of a county traffic ordinance in which the defendant has plead guilty, according to the requirements of section 211.435, RSMo. No such surcharge shall be collected in any proceeding involving a violation of an ordinance when the court has dismissed the charge against the defendant, or when costs are to be paid by the county. Such surcharge shall be collected and disbursed by the clerk of the court as provided by sections 488.010 to 488.020, RSMo. The surcharge collected under this section shall be paid into the state treasury to the credit of the juvenile justice preservation fund created by section 211.435, RSMo. The provisions of this subsection shall expire on August 28, 2024. Section 211.435, RSMo.

#### [I] m. Domestic Violence Shelter Surcharge.

A surcharge of four dollars (\$4.00) shall be assessed for the violation of a county ordinance, except that no surcharge shall be collected when the proceeding or defendant has been dismissed by the court or when costs are to be paid by the county. The surcharges levied pursuant to this subsection shall only be used for the purpose of providing operating expenses for shelters for battered persons as defined in sections 455.200 to 455.230, RSMo. Section 488.607, RSMo.

[m] <u>n</u>. Inmate Prisoner Detainee Security Fund Surcharge.

A surcharge of two dollars (\$2.00) shall be assessed for violation of a county ordinance, except that no such fee shall be collected when the proceeding or defendant has been dismissed by the court or when costs are to be paid by the county. All such surcharges shall be payable to the county treasurer, who shall deposit those funds in an Inmate Prisoner Detainee Security Fund, to be utilized to develop biometric identification systems to ensure that inmates can be properly identified and tracked within the county jail system. Section 488.5026, RSMo.

#### [n] o. Law Enforcement Arrest Costs.

In addition to any other penalties imposed, the court may order a defendant who pleads guilty or is found guilty of violation of or any alcohol or drugrelated traffic offense to reimburse the county for the costs associated with his arrest, including the reasonable cost of making the arrest, the cost of any chemical tests to determine the alcohol or drug content of the defendant's blood, and the cost of processing, charging, booking and holding the defendant in custody. The Sheriff may establish a schedule of such costs for submission to the Court. The costs herein provided shall be collected by the authorized clerk and deposited into the county treasury for deposit in a fund for the provision of services by sheriff. Section 488.5334, RSMo.

#### [o] p. Law Enforcement Training Fund Surcharge.

A surcharge of two dollars (\$2.00) shall be assessed for the violation of a county ordinance. No such surcharge shall be assessed when the proceeding or defendant has been dismissed by the court or when costs are to be paid by the county. The surcharges collected pursuant to this subsection shall be transmitted to the County Director of Finance and Purchasing for deposit in a fund law enforcement training in accordance with section 488.5336, RSMo.

## 1810.3 <u>Costs Not Assessed, When</u>.

Costs shall not be assessed as provided in this section in those cases where the defendant is found by the judge to be indigent and unable to pay the costs. Additionally, the costs authorized in subsection 1810.2(f) may be reduced if the court determines that the schedule of costs is excessive given the circumstances of the case or for good cause shown.

## 1810.4 <u>Other Charges</u>.

Costs authorized by this section are in addition to service charges, witness fees, and jail costs that may otherwise be authorized to be assessed. Effective Date: This ordinance shall be effective immediately upon its signature by the County Executive.

## IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

**AN ORDINANCE** repealing sections 1051., 1054., 1070., and 1071., <u>Jackson County</u> <u>Code</u>, 1984, relating to County purchasing, and enacting, in lieu thereof, two new sections relating to the same subject.

**ORDINANCE NO. 5626,** June 6, 2022

**INTRODUCED BY** Tony Miller, County Legislator

WHEREAS, with the implementation of the County's new Bonfire procurement portal, an amended to chapter 10 of the County Code is necessary to ensure that the County's new bid advertising and bid opening procedures are accurately reflected in the code; and,

WHEREAS, an amendment is also necessary to implement the recent transition of the bidding responsibility for construction projects in the Parks + Rec and Public Works Departments back to the Department of Finance and Purchasing; and,

BE IT ORDAINED by the Legislature of Jackson County, Missouri, as follows:

## Section A. Enacting Clause

Sections 1051., 1054., 1070., and 1071., <u>Jackson County Code</u>, 1984, are hereby repealed, and two new sections enacted in lieu thereof, to be known as sections 1051. and 1054., to read as follows:

## 1051. Formal Competitive Bids, Notice Inviting.

Notice inviting bids shall be provided in the manner and utilizing such media as the Director of Finance and Purchasing or his or her designee deems most appropriate to the

subject matter of the bid and the applicable time line available with the objective of encouraging fair and unbiased competition. The notice shall be designed to secure a reasonable distribution and a competitive bidding process and may include direct mail, electronic mail, on-line listing services, <u>the County's online procurement portal at jacksongov.org</u>, newspaper advertisements, and/or such other means as the director may deem appropriate. In addition to any other solicitation, all purchases, leases, or sales shall also be advertised by notices posted on public bulletin boards in the courthouses in Kansas City and Independence.

#### 1051.1 Notice of Solicitation, Content, Timing.

The notice inviting competitive bids shall be distributed and/or posted at least five (5) business days preceding the last day for receipt of bids or proposals and shall include a general description of the products or services to be leased or purchased and state where bid forms and specifications may be obtained and the time and place for submission and opening of bids.

#### 1051.2 Bidders and Suppliers List.

The Director of Finance and Purchasing shall review the bidders and suppliers list for prospective bidders and shall solicit bids from as many such bidders as is necessary to assure a reasonable distribution of the solicitation and adequate competition.

#### 1051.3 Certain Solicitations, Evaluation Process.

Each solicitation that is to be accomplished by way of a Request for Proposals, Request for Statements of Qualifications and Interest, or a similar procurement mechanism, and that will result in a recommendation to the County Legislature for the award of a contract, shall contain in the notice and/or specifications the following statement: "Any Evaluation Criteria or weighting of criteria is used by the County as tool to assist the County in selecting the best proposal for the County. Evaluation scores or ranks alone do not create a right or expectation of a Contract or Agreement with the County."

#### 1054. Procedure for Receiving and Opening Bids.

The following applies to bids submitted under the formal competitive bid procedure:

## 1054.1 [Sealed and Identified] Submission.

All bids shall be submitted in [a sealed envelope to the Director of Finance and Purchasing and shall be identified as bids on the envelope] the manner specified in the bid solicitation.

#### 1054.2 Bid Opening.

Bids shall be <u>reviewed</u>, opened, and [read aloud publicly] <u>recorded</u> by the Director of Finance and Purchasing or his or her duly authorized representative [in the presence of the Clerk of the County Legislature or the duly authorized representative of the clerk in the courthouse at Kansas City or Independence, in the particular room and] on the day and at the time stated in the public notices, [except that bids for construction projects undertaken pursuant to sections 1070. and 1071. of this chapter may, upon proper notice, be opened in the office of the Director of Public Works] <u>and secured in a manner that prevents tampering</u>.

#### 1054.3 [Bids Recorded.

The Clerk of the County Legislature, or his or her duly authorized representative, shall record in writing the bids opened and read by the Director of Finance and Purchasing.

#### 1054.4] Bid Evaluation and Recommendations.

The Director of Finance and Purchasing shall evaluate the bids submitted and refer his or her recommendations to the appropriate department head, who shall within the shortest practicable time, confirm the recommended award or submit objections and suggestions to the director. Such objections and suggestions shall include specific reference to the manner in which the department head believes an alternate bid complies with the provisions of subsection 7 of this section.

#### 1054.[5] <u>4</u> <u>Rejection of Bids</u>.

The Director of Finance and Purchasing shall have the authority to reject, as often as he or she deems necessary, all bids, parts of all bids or all bids for any one or more supplies or contractual services included in the proposed contract, for failure

to comply with the requirements of the invitation for bids or when the public interest will be served thereby, and require the solicitation of new bids.

#### 1054.[6] 5 Recommend Award of Bid.

The Director of Finance and Purchasing shall recommend to the County Legislature the award of the contract to the lowest and best bidder, unless all bids have been rejected as authorized in subsection [5]  $\underline{4}$  of this section.

## 1054.[7] <u>6 Factors Which Shall Be Considered When Determining Lowest and Best</u> Bidder.

The following factors shall be considered in determining the bidder that provides the best products and/or services that are available for the lowest price:

## a. Cost and Future Maintenance.

The point of purchase cost of the product or service, the anticipated cost of maintenance or service (including applicable warranties), the ability of the bidder to provide future maintenance and service, the longevity of the product or service, and the cost of disposal.

## b. Ability to Perform.

The ability, capacity, skill, or financial resources of the bidder to perform the contract or provide the service required;

## c. Timely Performance.

Whether the bidder can perform the contract or provide the service promptly or within the time specified without delay or interference;

## d. Character and Reputation.

The character, integrity, reputation, judgment, experience, and efficiency of the bidder;

## e. Quality of Prior Performance.

The quality of the bidder's performance of previous contracts or services;

## f. Compliance With Laws.

The previous and existing compliance by the bidder with laws and ordinances relating to the contract or service;

## g. Quality and Availability.

The quality, availability, and adaptability of the supplies or contractual services to the particular use required;

## h. Conditions on Bid.

The number and scope of conditions attached to the bid;

#### i. Compliance With Bid Specifications.

Whether the bid as submitted fully complies with the minimum requirements of the bid specifications;

#### j. Environmental Preference.

The environmentally preferable nature of the product or service when compared with competing products or services that serve the same or similar purposes. This comparison may include consideration of raw materials acquisition, production, manufacturing, packaging, distribution, reuse, operation, transportation of the product to the County from its point of origin, maintenance, and/or disposal of the product.

#### k. Social Responsibility.

The socially responsible nature of the product or service which shall include, but is not limited to, products or services that create meaningful work, encourage diversity, include women-owned and minority-owned enterprises, provide fair wages, or otherwise promote social equity.

#### I. Local Preference.

A bidder domiciled in Jackson County or whose products and services were manufactured, created, or have points of origin within

Jackson County will be given a preference and a local bidder (a business in close proximity to Jackson County) will be given a secondary preference, when all other considerations are equal and the bidder is compliant with all provisions of this code.

#### 1054.8 Analysis When Service Contracts are Bids.

Notwithstanding any other provision of this chapter, when a contract for services is to be awarded under the competitive bidding provisions of this chapter the Director of Finance and Purchasing shall perform an analysis of the respective bids submitted and shall submit such analysis to the Legislature for its consideration.

#### [1070. Construction Projects, Bid Process.

Except as otherwise provided by law, the Director of Finance and Purchasing shall solicit bids and let contracts for construction projects in the manner provided in this chapter. The Director of Public Works shall cooperate with the Director of Finance and Purchasing in the preparation of specifications, solicitation of bids, and bid analysis on construction projects.]

#### [1071. <u>Construction Projects for the Parks and Recreation Department</u>.

When requested by the Director of Parks and Recreation, the Director of Public Works shall solicit bids and let contracts on construction projects for the Parks and Recreation Department in the same manner as the Director of Finance and Purchasing solicits bids and lets contracts on other County purchases. The Director of Finance and Purchasing

#### COOPERATIVE AGREEMENT FOR DESIGN SERVICES TO RESTORE JACKSON COUNTY LONGVIEW TRAIL IMPACTED BY <u>REPLACEMENT OF RAYTOWN ROAD DOUBLE-PIPE CULVERTS</u>

This Cooperative Agreement is made as of May \_\_\_\_\_, 2022, between Jackson County, Missouri (the "County"), and the City of Grandview, Missouri (the "City").

#### Recitals

**A.** Heavy rainfall over the years has caused erosion and settlement of a double-pipe culvert under Raytown Road and the Longview Trail.

**B.** The City retained Alfred Benesch & Company ("Benesch") to design replacement of the failed culverts.

**C.** Benesch recommended that bridge structures be built on Raytown Road to replace the existing culverts that will impact and require the placement of a new bicycle and pedestrian trail bridge crossing over the area where the existing culverts will be removed. (the "Project").

**D.** In order to avoid delay of the Project and to eliminate coordination conflicts, the City and County have agreed to include design of the County's new pedestrian bridge in the overall design services for the Project.

**E.** County agrees that Benesch, the City's design consultant for the City's Project, is the appropriate design firm for design services for the new pedestrian bridge.

**F.** County agrees to make payment to City in advance for overseeing design work for the new pedestrian bridge.

**G.** An amendment to this Cooperative Agreement will be negotiated in the future if County approves a bid for construction of the Project procured by the City, including an alternate bid for the new pedestrian bridge. The amendment is necessary to cover the cost of construction and inspections of the new pedestrian bridge, which will be paid by the County to the City before construction begins.

Therefore, the parties agree as follows:

#### A. Design and construction of replacement Raytown Road pedestrian bridge.

Construction of the new pedestrian bridge adjacent to Raytown Road will be included in the City's Project as an alternate bid. The County is responsible for the cost of the design of the new pedestrian bridge and will be responsible for the cost of construction if the alternate bid is acceptable.

#### i. Obligations of County. County agrees to:

Expend only local dollars in the Project including the funds to be remitted to the City or used to pay the contractor. In no event shall federal funds received by the County be used for this project.

Remit to City, upon approval of this Cooperative Agreement by County Executive, the sum of Twenty Thousand Six Hundred and Twenty-One Dollars (\$20,621.00) for design of the new pedestrian bridge near Raytown Road; provided however that if City fails to fulfill its obligations as set forth in this Cooperative Agreement, County shall be entitled to withhold in full, or recover in full if already remitted to City, County's contribution.

Remit design criteria to City for the new pedestrian bridge in a timely manner and in general accordance with the adopted Project design schedule.

Review and approve plans and specifications submitted by City in a timely manner and in general accordance with the adopted Project design schedule.

Negotiate an amendment to this Cooperative Agreement with City, upon acceptance of the alternate bid for the new pedestrian bridge, for the sum necessary to cover the cost of construction and inspections of the new pedestrian bridge.

If the alternate bid is unacceptable, the County would have the right to re-bid the new pedestrian bridge construction as a separate project utilizing the design produced by Benesch.

Comply with all other requirements applicable to County as set forth in this Cooperative Agreement.

ii. Obligations of City. City agrees to:

Accept the sum of Twenty Thousand Six Hundred and Twenty-One Dollars (\$20,621.00) from County and maintain the same intact to be spent exclusively on the design of the new pedestrian bridge set forth in this Cooperative Agreement and none others.

Exercise general supervision over the design of the new pedestrian bridge. The design year shall be 2022.

Ensure that all plans, drawings, and specifications for the new pedestrian bridge conform to County's standards for structures, subject to County's right to issue variances to these standards as it deems necessary.

Provide to County the new pedestrian bridge plans and specifications at key milestones for County's review, comments and final approval. Ensure final

approval is received from County prior to advertisement for the Project. Deliverable plans and specifications will include Preliminary plans, Final Plans and Project Manual (technical specifications) for the Project.

Bid the City's Project through the City's standard bidding procedures, anticipated for 2022, with the costs for the construction of the new pedestrian bridge as an alternate bid on the City's bid form, which will ensure costs to construct the new pedestrian bridge are evident.

Negotiate an amendment to this Cooperative Agreement with County, upon acceptance of alternate bid for new pedestrian bridge, for the sum necessary to cover the cost of construction and inspections of the new pedestrian bridge.

Provide to County an accounting sufficient to satisfy County that the funds contributed by County herein were spent in accordance with the terms of this Cooperative Agreement and provide such additional supporting documentation as may be required by County to establish City's compliance with all other terms and conditions of this Cooperative Agreement.

Comply with all other requirements applicable to City as set forth in this Cooperative Agreement.

**B. Execution Documents.** This Cooperative Agreement may be executed in one or more counterparts, each of which shall constitute an original and all of which, when taken together, shall constitute one agreement.

**C. Authority.** This Cooperative Agreement is entered into by the parties pursuant to the authority set forth in Article VI, Section 16 of the Missouri Constitution and RSMo §70.210 et. seq.





Jackson County is requesting a grant extension for award 2018-DJ-BX-0180. The request is to extend the grant period for 12 months to allow additional time for the Jackson County Prosecutor's Office to fully expend funding.

Jackson County was allocated \$62,764.00 from the grant award for a KCNoVA Data and Analyst position. The data analyst converts information acquired through investigations and prosecutions into useable criminal intelligence in the form of data maps, searchable databases, coordinates with other law enforcement partners to identify potential crimes trends to provide recommendations on organizational changes that help focus resources on cases, programs, and policies that will provide the greatest results in reducing violent crime in Jackson County.

The community's violence-reduction program continues to build on law enforcement intelligence efforts, continuing weekly meetings in which all enforcement and intelligence units gather, including prosecutors and federal agency representatives, to build and share information on crime drivers in Kansas City. The data analyst is a crucial part of this effort as part of the Crime Strategies Unit (CSU). With the information maintained by the analyst, the unit produced a new data dashboard that shows the community all criminal cases and their status, as well as all fatal and non-fatal shootings reported each week by the Kansas City Police Department. This data is giving the community and our partnership a more robust portrait of the crime in our community and the areas in need of improvement, including clearance rates that typically trail the national average. In the last few months, the office also used this data to develop a referral system for social services to shooting victims. These referrals will result in client advocates assessing and helping recent shooting victims with a variety of services.

Jackson County began using grant 2018-DJ-BX-0180 in February 2021. Jackson County will fully expend the grant by December 2022.

Due to the COVID-19 pandemic, Jackson County cancelled all work-related travel. At this time, Jackson County is hopeful work travel can resume within the next year. If allowed to travel, Jackson County will fully expend the grant by December 2022.

Jackson County was allocated \$11,894.00 from the grant award for equipment replacement for office staff. Due to the COVID-19 pandemic, Jackson County employees worked remotely from March 2020 through July 2021. Since returning to full staff capacity, our office has now begun the process to replace older equipment. Jackson County will fully expend the grant by December 2022.

The remaining balance of the total grant is \$81,513.99.

#### **Request Summary**

The Collection department requires service to Post Notice of Foreclosure signs on properties in the Delinquent Land Tax Sale. The Purchasing department issued Invitation to Bid No. 38-22 in response to those requirements, but received no bids. Last year this project went out to bid and only received one response.

Collections later identified Civic Source as a vendor which did other types of work with County tax sales and therefore Director Miller approached them to see if they could provide this service for this year. Civic Source has prior experience providing this service in other states and would be able to help us meet all of our County code and State statutory requirements.

This vendor is different than our previous vendor in that they also request a parcel list to do their own initial mapping to ensure trip efficiency. We are requesting this sole source option for this year only and only for the posting services. We would go back out to bid for next year's tax sale process and would update our specifications based on what changes to our process are determined to be effective this year. Pursuant to Chapter 10 of the Jackson County Code, Section 1030.1, the Collection Department and the Purchasing Department are recommending this award.

Per the attached quote of \$35.00/posted notice, estimated 2022 usage is \$41,685.00 based on 5/17/22 parcel count. **RE:** Sole source vendor for Tax Sale Posting Process 2022

State statutes and the County Code related to Jackson County's tax sale process require that each property set to be sold in our tax sale be physically posted with a notice. This requires teams of people to go out into the County to drive stakes and attach notices, take photos, and enter the information into our software. It is difficult and time-consuming work, and we no longer have the capacity to do it with departmental staff or County staff volunteers.

Last year we went out for bid and only got one response. The responding vendor performed the work last year. We did not receive any responses to this year's RFP.

Around the time of the opening of the RFP I had been speaking to this vender about other tax sale related services. When I learned we had no responses to the RFP, I reached out to this vendor who I knew did other types of work with County tax sales, such as process automation, notice generation, and online auctions to see if they would be interested in providing posting service. They have done notice posting in several other states and have decades of experience in assisting with tax sale notice services. This vendor is different than our previous vendor in that they also request a parcel list to do their own initial mapping to ensure trip efficiency. If we find this to be effective, we will go back out to bid next year and add this into our bid specs as a preference. The County will still provide all supplies and the vendor will go to each property to post the notice and collect the necessary information. The vendor will track who posts each property for purposes of our confirmation process. This year's process will be different in that the vendor will collect all supplies in the beginning of the project whereas last year they came to gather supplies each day.

To meet our statutory requirements for this year, we are requesting this sole source option for one year only & only for the posting services and would go back out to bid for next year's tax sale process. Pursuant to Chapter 10 of the Jackson County Code, Section 1030.1, the Collection Department, and the Purchasing Department are recommending this award.



## PROFESSIONAL SERVICE AGREEMENT

## SCHEDULE OF SERVICES

## INTRODUCTION

- 1. Term of Contract: The term of this Contract will be through September 1, 2022, or the last day of the Jackson County 2022 Tax Sale, whichever shall come first.
- 2. Posting Notice of Foreclosures will be on an "As Needed" basis.
- 3. Although exact usage cannot be determined, it is estimated that the number of properties will not exceed 1300.

## SPECIFICATIONS

- 1. The contractor is responsible for posting notice of foreclosure on properties with delinquent property taxes located within the Jackson County boundaries.
- 2. Jackson County will make available on or before June 16<sup>th</sup>, 2022, the pertinent information and equipment needed to complete the project. The project must be completed no later than July 15<sup>th</sup>, 2022.
- 3. Contractor will locate correct delinquent property according to legal description (not street address), hammer stake into the ground of property & staple notice to stake.
- 4. Contractor will take a picture of the completed posting and the property. Contractor will upload photo and enter property data into posting application.
- 5. Work is done in an outdoor environment on iPads. This contractor reports to the Delinquent Land Tax Administrator.
- 6. Prior to posting, the Contractor will be trained by the Department of Collection and/or County GIS on how to properly read the maps and operate the iPad and posting application. If appropriate, a County associate will join the Contractor on their first day of posting to ensure a proper understanding of the process.
- 7. Contractor should have enough driving & navigation skill to be able to safely navigate around Jackson County, using GPS & paper maps.
- 8. Contractor must be capable of using iPad for data entry, picture taking, & attaching photos.
- 9. Contractor must be capable of using a 5lb hammer repeatedly during the day for consecutive days.
- 10. Contractor will provide transportation and will guarantee drivers have a valid driver's license and active automobile insurance.
- 11. County will provide necessary equipment including the following: stakes, property cards, staplers, staples, tape, ipads, ipad chargers, hammers, vests, and a County Contractor ID badge.
- 12. The boxes of supplies will be checked out to the vendor with an inventory list at the beginning of the project. The vendor will maintain equipment during the project and return all equipment in working condition. The inventory list will be checked by Jackson County prior to final billing. Any missing or damaged equipment will be deducted from final invoice payment.
- 13. Daily check-ins with the Director, Deputy Director, or Administrator will occur to ensure the project is on track. The vendor will be required to create a schedule of staff and provide it to Jackson County. This schedule should include who works on a given day, which group they worked in, what grids they were assigned/completed, and what iPad they were assigned.
- 14. The contractor may have to communicate with taxpayers in person if approached, concerning the posting of notice of foreclosure. They should refer them to the Jackson County Collection department while maintaining composure and pleasant disposition.
- 15. The Contractor must remain available if needed to testify at a hearing on a later date if the posting of notices is placed into question, and/or agree to sign a notarized affidavit stating which properties they posted on which day.
- 16. It is highly recommended that the Contractor perform this project in pairs. It is helpful and most efficient to have a driver and a navigator, as well as one person to drive the stakes while the other operates the iPad.

## PRICING

- The Contractor shall be paid \$35 per posted notice. This price shall be inclusive of mileage but shall not include any signage or equipment. Contractor shall provide only personnel and a vehicle, and costs directly related to the personnel and the vehicle. All other materials, equipment, services, and tools shall be provided by County.

Background: The Anti-Crime Sales Tax fund authorizes the County to execute agreements and contracted services for the purpose of providing substance abuse treatment, prevention, and law enforcement school based

initiatives like services in Jackson County, and other anti-crime, anti-violence and anti-drug initiatives in the community.

**INTRODUCED BY** Theresa Cass Galvin, County Legislator

WHEREAS, MORE<sup>2</sup> was created in 2004 as a social justice organization representing different faith traditions, cultural backgrounds, races, and economic means, growing from twelve congregations to thirty-four congregations with many individual members; and,

WHEREAS, MORE<sup>2</sup> is active in issues surrounding criminal justice, education, healthcare, and immigration; and,

WHEREAS, MORE<sup>2</sup> has organized people with felony convictions into a group called "Our Voices" and launched a campaign called "Our Voice, Our Vote," to engage and educate eligible voters throughout Missouri and Kansas; and,

WHEREAS, it is the goal of MORE<sup>2</sup> to register 20,000 new voters by November 2022; and,

WHEREAS, research suggests voting has been linked to a reduction in recidivism and restoring voting rights to people impacted by the criminal legal system could aid their transition back into community life, encouraging law-abiding behavior; and,

WHEREAS, restoring the right to vote to people previously incarcerated enables them to exercise their lawful civil rights and civic duty; and,

WHEREAS, voting rights for formerly incarcerated individuals eligible to vote under section 115.133.2 of the Missouri Revised Statutes are fundamental to our democracy and our County; and,

WHEREAS, in Missouri, those with felony or misdemeanor convictions are eligible to vote upon completion of their sentence and probation or parole and individuals who have been convicted of an election offense, whether a felony or misdemeanor, are not allowed to vote; and,

WHEREAS, in a 2018 Pew Research Center survey, 69% of Americans agreed with allowing people convicted of felonies to vote after serving their sentence with a majority of both Republicans and Democrats in support; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the Legislature hereby recognizes MORE<sup>2</sup> for its efforts to educate, engage, and register eligible voters with misdemeanor or felony convictions throughout Jackson County.
