Project/Title:

A RESOLUTION authorizing the County Executive to execute an Agreement with, and Missouri Quit Claim Deed in favor of, the United States Fish and Wildlife Service, in accordance with the United States Swamp Lands Act of 1850, related to the Jackass Bend Unit, and known also as Big Muddy National Fish and Wildlife Refuge Acquisition Tract Number 110,R. at no cost to the County.

Request Summary

The Big Muddy National Fish and Wildlife Refuge was established in 1994 for the development, advancement, management, conservation, and protection of fish and wildlife resources for the continuing benefit of the American people. The Refuge spans from Kansas City to St. Louis along the Missouri River floodplain, encompassing 17 separate units of protected lands and offering a variety of educational and recreational opportunities to the public.

The Jackass Bend Unit of the Big Muddy NFWR is located approximately 45 minutes northeast of Kansas City. The U.S. Fish and Wildlife Service acquisition would provide high quality public use opportunities within the Kansas City major metropolitan area. It would allow enhanced public access to the Jackass Bend Unit, including exceptional fishing, hunting, and wildlife observation opportunities. After acquisition, the Refuge Manager plans to implement a public youth waterfowl hunting program to increase environmental education and recreational access.

U.S. Fish and Wildlife Service is requesting that Jackson County relinquish their rights to the abandoned riverbed to the U.S. Fish and Wildlife Service, in order to consolidate title, complete acquisition of the area, and allow Big Muddy National Fish and Wildlife Refuge to provide exceptional public access opportunities.


