Dear County Executive Frank White, Jr.,

Over the past several years, the Jackson County Sheriff's Office has received several donations of military style vehicles from the LESO (Law Enforcement Support Office) program. These vehicles were provided to the Sheriff's Office for usage as the Sheriff's Office saw fit, but they are no longer being used as originally intended. Further, several of these vehicles are no longer in running condition, and the cost to repair them is extensive. The Sheriff's Office is under no contract to keep the items as LESO does not consider the vehicles property of Jackson County. Neither are they to be returned to the LESO program.

The Clinton County Sheriff's Office has now expressed interest in these vehicles and would like to take possession as soon as possible. The vehicles referenced are: one (1) five-ton truck, one (1) five ton "wrecker", two (2) bridge building boats, one (1) HMMWV utility truck, and two (2) utility trailers. In addition, Jackson County purchased two (2) boat trailers. Deputy Cheney has confirmed with LESO staff the Clinton County Sheriff's Office can take direct possession of the LESO items when we relinquish them. In addition, we are working with Ms. Katelyn Edgar in Purchasing to request legislative approval to surplus the boat trailers, which is not anticipated until mid to late January. Therefore, I would like to allow Clinton County to take immediate possession of all the above listed items, with the exception of the boats and trailers. Then, upon surplus approval of the trailers, Clinton County can take possession of them.

The Clinton County Commissioners have contacted Deputy J. Cheney as he currently handles the LESO vehicles. They have requested written confirmation the vehicles do not belong to Jackson County and Jackson County has no concerns with Clinton County taking them.

County Executive White, it is my request that a letter be provided with your signature assuring the Clinton County Commissioners that Jackson County has no interest in these vehicles, and they may be transferred to Clinton County, MO.

Dear Ms. Edgar,

Over the past several years, the Jackson County Sheriff's Office has purchased numerous ballistic vests for our members' daily wear. The vests are all given an expiration date by the manufacturer, and upon expiration, they have been shredded, to prevent them from being used in illegal activity.

Recently, a former Kansas City Police Officer, who now works for Freedom Shield Foundation (FSF), reached out to Major Fletcher and requested any and all of our ballistic vests that, although expired according to the manufacturer, still may have some ballistic use to them. According to Mr. Scott Braddock, their Controller, Freedom Shield Foundation is a 501c3 organization primarily made up of former Navy Seals and law enforcement officers, who will pay for our expired vests to be shipped from the Jackson County, MO Sheriff's Office to the Ukraine military. In addition, Mr. Braddock advised he will provide shipping receipts, photos, and videos to verify the vests made it to Ukraine.

Attached is a Surplus/Transfer Declaration Form in which the vests intended to be transferred are listed. Please accept this as verification the Sheriff's Office would like these transfers and are requesting them at your earliest convenience to assist the Ukraine military in their efforts.
