### Introduction

A Resolution nominating candidates for appointment to the Jackson County Sports Complex Authority, for a term to expire July 15, 2027.

### Request Summary

The term of Garry Kemp as a member of the Jackson County Sports Complex Authority expires on July 15, 2022, and this will result in a vacancy of the authority.

Pursuant to section 64.930 RSMo and case law construing said section, in the event a vacancy exists, a panel of three nominees shall be submitted by majority vote of the County Legislature to the governor for his consideration for final appointment to fill the vacancy.

This requested resolution will direct the Legislature to nominate a panel of candidates to fill the vacancy on the Jackson County Sports Complex Authority occasioned by the expiration of the term of Garry Kemp, for a new term to expire July 15, 2027.

After the Legislature votes on its panel of nominees, the Clerk of the Legislature is directed to submit this panel to the governor's office for final appointment.
