The body armor manufacturer indicates the body armor becomes less safe over time, as heat and moisture breaks down the synthetic fiber, and highly recommends the body armor be replaced within five years.

The Task Force recommends the purchase of 23 sets of body armor from Galls LLC, Lexington, KY, an approved Jackson County vendor.
