## AMENDMENT TO COOPERATIVE AGREEMENT R. 20681

The Cooperative Agreement R.20681, between Jackson County, Missouri, a Constitutional Home Rule Charter County of the First Class of the State of Missouri (County) and the Metropolitan Arts Council of Greater Kansas City (dba ArtsKC - Regional Arts Council), a Missouri not-for-profit corporation (Organization), with the effective date of May 1, 2021 is hereby being amended and modified as follows:

Term of the Agreement: May 1, 2022 through March 31, 2023.

<u>Terms of Payment:</u> The County agrees to pay Organization the total amount of \$250,000 for the following scope of services as defined below with specific work defined and payment terms as noted below in the Scopes of Services.

<u>First Scope of Services:</u> The effective start date for this scope of work is May 1, 2022. It is for a continuation of advancing the arts and culture infrastructure, as commenced in the original Cooperative Agreement. This scope of work includes:

- Establish Governance Structure and Leadership
- Continue Community Outreach and Asset Mapping
- Develop a long-term strategy to measure impact that may include:
  - Social impact data collection and analysis
  - Design and implement a data visualization tool
- Provide overall project management and leadership of the project.


Total payment for this scope of services is \$125,000 and shall be made upon execution of this agreement. The Budget for this scope of services is provided herein as Exhibit A.

<u>Second Scope of Services</u>: The effective date for this scope of work is July 1, 2022. It is for Impact Funding. Organization agrees to provide Impact Funds to Jackson County residents or entities to further the impact of the arts and culture upon the County. The Budget for this scope of services is provided herein as Exhibit A.

Total payment for this scope of services is \$125,000 and shall be made upon Organization providing invoice materials to document said investment funding.

<u>Contract Ending Date:</u> For all scopes of services, the Cooperative Agreement ending date will be March 31, 2023.

<u>Conditions for Payment</u>: The first scope of services payment will be considered an advance of payment under this Cooperative Agreement and is subject to final submission of an invoice to support said scope of services. The second scope of services, as noted above will be made following submission of an invoice. The County reserves the right to audit all invoices and to



reject any invoice for good cause. The County retains the right to deduct from an invoice of Organization any overpayment made by the County on a prior invoice.

<u>Reports/Other Documentation:</u> Organization will submit a final report following the conclusion of the Cooperative Agreement, currently due in April 2023. It will also submit proof of payment and receipt documentation that reconciles to the report. All payments will be processed within 30 days of receipt of invoice, if the invoice is complete and accurate. All payments will be detained until reports are received and accurate. Any unspent funds under this Agreement not invoiced by Organization within 30 days from the expiration of this Agreement shall be forfeited and not be paid.

<u>All Other Sections of the Cooperative Agreement</u>: All other sections of the Cooperative Agreement not noted above as amended shall remain in full force and effect.
