A resolution authorizing the County Prosecutor to execute agreements with certain outside agencies funded by the County's Anti-Crime Sales Tax Fund for the 2023 fiscal year, which are engaged in anti-crime and anti-violence prevention, treatment and law enforcement school based initiative activities and purposes, not to exceed \$12,277,283.

Request Summary

A resolution authorizing the County Prosecutor to execute agreements with certain outside agencies funded by the County's Anti-Crime Sales Tax Fund for fiscal year 2023, which are engaged in anti-crime and anti-violence prevention, treatment and law enforcement school based initiative activities and purposes, not toexceed \$12,277,283.

Exhibit A lists the outside agencies and funding levels as recommended by the Jackson County COMBAT Commission for fiscal year 2023.

Background: The Anti-Crime Sales Tax fund authorizes the County to execute agreements and contracted services for the purpose of providing substance abuse treatment, prevention, and law enforcement schoolbased initiatives, like services in Jackson County, and other anti-crime and anti-violence initiatives in the community. These recommendations are based upon proposals submitted by community providers in response to COMBAT's request for proposals. Funding recommendations were presented to the Jackson County COMBAT Commission on January 12, 2023, with the recommendation that the funding recommendations in Exhibit A be presented to the Jackson County Legislature.
