Request Summary

WHEREAS, Jackson County Missouri relies upon both Personal and Real Property taxes as a principal source of revenue; and,

WHEREAS, numerous pieces of legislation contemplate eliminating or reducing property tax revenue to local taxing jurisdictions; and,

WHEREAS, current property tax law and processes create considerable negative effects on the citizens of Jackson County, including financial hardship, potential for foreclosures and evictions; and,

WHEREAS, Jackson County Questions 1 – A County-wide sales tax on sales of non-medicinal marijuana may represent a substantial new revenue source whose amount cannot yet be determined; and, WHEREAS, it is in the best interest of Jackson County Missouri to reduce our reliance on personal property taxes and owner occupied residential property taxes; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri that if Jackson County Missouri Question 1 is passed by a majority of voters, we intend to sequester the unknown amount of revenue until the end of each fiscal year at which point we intend to utilize no less than 85% of the new revenue generated as a result of Question 1 to offset & reduce the county's reliance upon Personal and Real Property Taxes.
