#### Introduction

#### Project/Title:

Authorizing the purchase of one (1) UV34 Bobcat Gas Utility Vehicle for \$15,107. This piece of equipment will be purchased from Clark Equipment, under the terms and conditions of NASPO GME E194-81037, an existing competitively bid government contract. This Contract offers an 18% discount which is reflected on the Bobcat Quotation MMB-03048.

#### **Request Summary**

Pursuant to Section 1030.4 of the Jackson County Code, Parks + Rec and the Purchasing Department recommend the purchase of one (1) Bobcat UV34 Gas Utility Vehicle at a cost of \$15,107. The Gas Utility Vehicle will be purchased from Clark Equipment under the terms and conditions of the NASPO Ground Maintenance Equipment Contract E194-81037, an existing competitively bid contract. This utility vehicle will be used in rough terrain and in unimproved trail areas within the park system by our Natural Resources work group to perform environmental surveys, treat and/or remove invasive species, and other activities associated with properly maintaining the largely unimproved areas of the 21,000 acre park system.

Funding is available within the Department's approved 2023 Budget, Account 1010-003-58110 for this purchase. The cited NASPO GME Contract and quotes are attached for review and reference.
