Introduction

Project/Title:

Amending Chapter 2 of the Jackson County Code of Ordinances by updating the provisions of Schedule 1 and adding several new positions in the County Auditor's Office and an Colonel position in the Sheriff's Office.

Request Summary

This ordinance proposes an Update to Schedule 1 of Chapter 2 of the Jackson County Code of Ordinances. Under the County Legislature section of Schedule 1, all positions under the County Auditor are now listed as non-merit positions and several are given new grade levels reflecting the recent reorganization of staff within the County Auditor's Office.

Other changes include the adjustment upwards by one pay grade of all deputy director (310) and department director (360) positions throughout the County reflecting the changing labor market. In addition, a Colonel position (370) is added in the Sheriff's Office. Lastly, this amendment removes all of the 2022 pay scales from Schedule I. Salary grades for all positions in the County are adjusted annually and will be maintained by the Department of Human Resources going forward
