Request Summary

Various County Departments require a Term and Supply Contract for the furnishing of HVAC Services. The Purchasing Department issued Invitation to Bid No. 23-015 in response to those requirements. A total of 356 notifications were distributed, twenty-two (22) takers with three (3) responses received and evaluated. During the evaluation process, one submission was eliminated for their response to this bid. An Executive Summary of the Invitation to Bid, including the Contractor's Quotations and the using departments Recommendation Memos are attached.

Bids submitted were from the following:

- US Engineering Service, LLC
- Emcor Services Fagan
- Carrier Commercial Service

The Parks + Rec Department's recommendation is to split award to US Engineering Service and Emcor Services Fagan for HVAC Services. Given that HVAC systems repairs/replacements are generally unforeseen, and that issues that occur may come at peak busy times for the contractor, e.g. start of furnace or air conditioning season, having two companies available to perform repair/replacement work is essential.

Both recommended contractors have long business histories and well-qualified staff. Emcor Services has lower hourly rates and 10% less mark up than US Engineering, however, US Engineering has familiarity with many of the Parks HVAC systems and carries the warranty on multiple units they have installed within the last 18 months.

Parks + Rec projected usage during the next twelve months is \$80,000, subject budget approval/availability.
