#### **Project/Title:**

Authorizing the extension of current term and supply contract 58-18 for Lockbox services with UMB Bank of Kansas City, MO for use by the Collection department from November 13, 2023 through March 31, 2024.

#### **Request Summary**

On November 5, 2018 the Jackson County Legislature approved Resolution 20033, awarding a term and supply contract for the furnishing of Lockbox services for use by the Collection department to UMB Bank of Kansas City, MO under the terms and conditions of RFP58-18.

On November 22, 2021 the Jackson County Legislature approved Resolution 20822 to execute an addendum to include additional services for Lockbox.

This current contract expires November 12, 2023. A new request for RFP has been submitted in Bonfire, but unfortunately, there will not be enough time for the entire bid process to complete through award and purchase order prior to our necessary "vendor go live" date for the 2023 billing season.

Therefore, the Collection department is requesting to extend our current agreement TS58-18 with UMB from November 13, 2023 through March 31, 2024 to ensure that end of year mailed tax bill payments will all be timely processed by our existing lockbox processor.

We still intend for our RFP request for Lockbox services to go out for bid, but now it will be for services beginging in April 2024.

Collections is hereby requesting an extension of 58-18 from November 13, 2023 through March 31, 2024 in an amount not to exceed \$40,000 for this time period; \$31,000 for the 2023 budget year, and \$9,000 for the 2024 budget year to UMB Bank of Kansas City, MO. There are suffcient funds for 2023 purchase order of \$31,000 in 001-1403-56735-999-9999-23.
