Authorizing the addition of a Eight (8) Month Extension for the furnishing of Galvanized and Aluminized Type 2 Corrugated Culvert Pipe and Fittings for use by Various County Departments to Kansas City Winwater Works Company of Kansas City, MO, under the terms and conditions of City of Kansas City, Missouri Contract No. EV2571, an existing government contract.

Request Summary

The initial term of the City of Kansas City, Missouri Contract No. EV2571 expired on July 29, 2023. On September 14, 2023 the City of Kansas City, Missouri renewed the contract for an additional twelve (12) month period which is set to expire on July 31, 2024 with no changes in price, terms or conditions. This extension to this contract will allow the continuous use for the need of this service.

Pursuant to Section 1030.4 of the Jackson County Code, the Purchasing Department recommends the authorization of an adding a Eight (8) Month extension for the furnishing of Galvanized and Aluminized Type 2 Corrugated Culvert Pipes and Fittings under the terms and conditions set forth in the City of Kansas City, Missouri Contract No. EV2571, a competitively bid government contract.

The award is made on an "as needed" basis and does not obligate Jackson County to pay any specific amount. The availability of funds for specific purchases is subject to annual appropriations.
