WHEREAS, the Jackson County Family Court Division has been awarded a grant by the State of Missouri Office of State Courts Administrator in the amount of \$11,205.00, to provide funding for its Mediation Program, to create and implement domestic relations programs; and,

WHEREAS, the grant is awarded for the period of July 1, 2023, through June 30, 2024; and,

WHEREAS, an appropriation is necessary to place these grant funds in the appropriate spending accounts; now therefore,
