WHEREAS, the County Counselor now recommends an addendum to this contract to compensate Mr. Jurgeson for the time that will be necessary to adequately advise the BOE through the appeals dockets, at a cost to the County not to exceed \$50,000.00; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive be and hereby is authorized to execute an increase to the Legal Services Agreement with Ronald L. Jurgeson of Lee's Summit, MO, for a term ending December 31, 2024, at an additional cost to the County not to exceed \$50,000.00; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance and Purchasing be and hereby is authorized to make any and all payments required by the Agreement and all addenda thereto.
