provide assistance to homeless persons, at an aggregate cost not to exceed \$207,000.

Request Summary

Request for legislative action to authorize the County Executive to execute cooperative agreements with certain organizations which provide assistance to homeless persons. The 2024 budget is projected to provide for an allocation of \$207,000 to contract with agencies for the 2024 fiscal year.

On November 16th 2023, The Jackson County Purchasing Department released RFP #23-083 through the Bonfire System seeking proposals for 2024 Funding for Homeless Services for Homeless Individuals and Families in Jackson County, Missouri. RFP #23-083 closed on December 12, 2023. The Housing Resources Commission Board of Directors met with agency organization representatives to hear proposals on Thursday, January 25, 2024. From those hearings the Housing Resources Commission Board selected 11 agencies to receive funding in 2024.

Each agency selected for a funding allocation in 2024 by the Housing Resources Commission Board of Directors have met the County's liability insurance requirements, obtained tax clearance for taxes due/exempted as of December 31, 2023, and have submitted documents with their proposals that comply with Executive Order 04-18, thus are deemed in compliance with the requirements. The list of agencies and the amounts approved by board action are listed below.
