A RESOLUTION OF JACKSON COUNTY, STATING INTENT TO SUPPORT THE CITY OF GREENWOOD, MO SEEKING MULTI-JURISDICITONAL FUNDING THROUGH THE FT 23 and FY 24 COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM,

COMPETITIVE CYCLE, GENERAL INFRASTRUCTURE, FOR THE ALLENDALE LAKE ROAD IMPROVEMENT PROJECT. WHEREAS, Title I of the Housing and Community Development Act of 1974 does state as its primary objective “the development of viable urban communities, by providing decent housing and suitable living environment and expanding economic opportunities principally for persons of low and moderate income.” WHEREAS, Title I does offer to communities the opportunity of monetary assistance in accomplishing its stated primary objectives; and WHEREAS, The Missouri Department of Economic Development is designated to award Community Development Block Grant Funding under Title I; and WHEREAS, the County does have areas of need, General Infrastructure, Transportation Improvements, which may be addressed through the Community Development Block Grant Program. NOW, THEREFORE BE IT RESOLVED by Jackson County, that Jackson County supports the Missouri Department of Economic Development in the improvement of our community under the activities authorized pursuant to the Housing and Community Development Act of 1974. THEREFORE, BE IT FURTHER RESOLVED, that Jackson County is in full support of the project application to be submitted by the City of Greenwood, MO. No matching cash funds are required.
