WHEREAS, the execution of a Cooperative Agreement with No More Homeless Pets KC is in the best interests of the health, welfare, and safety of the citizens of Jackson County; now therefore.

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive be and hereby is authorized to execute a Cooperative Agreement with No More Homeless Pets KC, in the amount of \$80,000, in a form to be approved by the County Counselor; and,

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing be and hereby is authorized to make all payments, including final payment on the agreement.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.

# LOW-COST CARE IS A PET LIFE-SAVER

Agency offers services to owners who can't afford or don't have a private veterinarian.

nimal rescue agencies in the metro area see it every week.

Cash-strapped pet owners are forced to euthanize their beloved pet or

give the animal away to a shelter because they can't afford medical care.

No More Homeless
Pets KC is stepping up
to help. The nonprofit
agency opened a lowcost medical clinic Jan.
ll in Johnson County
to offer vaccinations,
dental work, heartworm treatment, surgery and general wellness and preventative care.

"Financial limitations will no longer keep pets from receiving the medical care they need," says No More Homeless Pets KC President, Gail Longstaff.

The facility at 5428 Antioch Drive in Merriam will be open from 10 a.m. to 6 p.m. Tuesday through Friday and 8 a.m. to 3 p.m. Saturday.

Some other rescue organizations offer limited vet services in Kansas City. Long-staff hopes this clinic will further efforts to provide high-quality, affordable care.

The group aims to serve those who don't already have or can't afford to pay for care from a private veterinarian.

"Our goal at No More Homeless Pets KC is to ensure that pets in our community are as happy, healthy as possible, and that owners who lack funds, yet provide a loving home, are not forced to give up or deny treatment to their companions," Longstaff said.

In doing so, the nonprofit's spokeswoman Courtney Thomas said, the clinic isn't designed to compete with private

"We're serving a demographic that has had no (vet services) prior to now," Thomas said.

> The agency will serve pet owners from across the area. Pet owners must prove financial need to use the low-cost services.

> The agency uses income guidelines to qualify customers. It also has a tiered price plan.

Thomas said the agency also wants

to create more relationships with private veterinarians. That way vets have a place to send clients who simply can't afford to provide the health care.

"We want (vets) to be able to refer them to us. The point is together — private veterinarians and No More Homeless Pets — we want to make sure that the pets in the community are as healthy as possible and living in a home with their owner," Thomas said.


Officials from the nonprofit agency have weighed the decision to open the clinic for some time.

"Every Friday, they were doing lowcost vaccinations and their lobby would just be full of people coming in for services," Thomas said.

Until Jan. 11, the group offered only vaccinations and spay and neuter services.


In 2010, the agency spayed and neu-

## **Proposed Program**

Creating and implementing programs geared to curb animal shelter intake, and prevent the euthanasia of adoptable animals is the driving mission of No More Homeless Pets KC. In 2009, more than 25,000 animals entered metro shelters, and over 30% of those animals were euthanized. The sad reality is most of the animals euthanized were adoptable, but the shelters simply ran out of space or did not have the resources to provide those animals with a viable outcome. No More Homeless Pets KC is eager to implement supportive programs to aid in the decline of animals entering and being euthanized in Jackson County shelters, while also providing affordable spay/neuter and veterinary wellness services to the community. Our HERO (Humane Education and Resource Office) program will target areas in Jackson County where we know the majority of shelter intakes/animal control calls originate.


Since 2007, over 20,000 spay/neuter surgeries have been performed at our facility. These spay/neuter initiatives have prevented thousands of unwanted litters from being born, thereby eliminating the chance that those litters would enter our area shelters. Continuing this trend to increase spay/neuter compliance will not only improve the lives of animals and citizens, but will provide a financial benefit to the city as it relates to decreased shelter intakes, along with additional support in the field to educate pet owners and provide them with necessary resources to keep the pet in the home.

While it is important to recognize the improvements to animal welfare that have been made across the metro the last several years, we still have a long way to go. In 2009, 7,108 animals were euthanized in Jackson County shelters, which accounts for nearly 87% of the total number of animals euthanized across the Kansas City Metro area (data includes Animal Haven, Independence Animal Control, Lee's Summit Animal Control, and Wayside Waifs). No More Homeless Pets KC would like to initiate the following programs in Jackson County.

- The HERO Program is an outreach initiative designed to educate pet owners about responsible pet ownership, provide resources such as food, appropriate outdoor shelter, medical care, and other necessary supplies, while also working with the pet owner to have their animals spayed or neutered. The HERO program manager will be out in the field five days a week, responding to calls for assistance, while also targeting zip codes where the majority of animal control calls and shelter intakes occur. This program also targets feral and free roaming cat populations to get colonies spayed/neutered and mitigate nuisance calls/issues.
- Our high-quality/low-cost spay and neuter program provides affordable (or free) services to pet owners. In addition, our transport services make it easy for communities or entire neighborhoods to participate. Our staff will pick the animals up, take them to NMHPKC for surgery, and deliver the animals back to the drop-off location the next day for owner pick-up.
- In January, we will launch our high-quality/low-cost veterinary wellness program. This program will provide an affordable option for pets who need medical attention, but whose owners have limited financial resources. No longer will pet owners have to consider surrendering their pet to a shelter as an option because they cannot afford medical care.

No More Homeless Pets KC is requesting funding to help provide the services mentioned above to citizens in Jackson County, focusing in particular on the zip codes 64055, 64056, 64057, 64124, 64125, 64126, 64127, 64128, 64130, 64132 in Jackson County. In 2009, the operating budget to support the Pet Outreach/ Spay and Neuter Programs was nearly \$290,000. 2010 has been in-line with 2009's budget, but projections for 2011 are expected slightly higher. With financial support from the county, we could expand the program and create a noticeable impact in Jackson County. We are requesting the county consider providing \$80,000 in funding to support these critical, life-saving programs.



Programs and services provided by No More Homeless Pets KC serve all Kansas City Metro communities. While the HERO program would be targeted specifically to the low income areas of the city, our plan is to focus on those areas of the community where the greatest need is identified. Additionally, in 2011 our goal is to increase our presence in eastern Jackson County, helping to reduce the number of unwanted litters born into this community through our spay/neuter initiatives, increase the quality of care provided to pets by their owners through our affordable veterinary care program, and provide resources necessary to keep pets in their homes with their owners thereby reducing shelter intakes. The primary targeted zip codes in eastern Jackson County for the HERO program, spay/neuter outreach and raising awareness to affordable veterinary care include 64055, 64056, 64057.

#### Fund Separation

Every client served by No More Homeless Pets KC is tracked in our computer database. We can easily generate reports that outline program penetration and success by county. Such reports are reviewed on a monthly basis. All calls for field services (i.e. HERO program) will also be tracked by city/county, and will be reviewed on a monthly basis. Funds received from Jackson County will aid in marketing/promoting programs in targeted Jackson County zip codes, and will allow us to provide low-cost spay/neuter services and veterinary wellness to Jackson County residents. 80% of the funding received from Jackson County will be directly tied to programs and services, and the remaining 20% to support staffing necessary to implement the programs.

## Approach & Method

- 1. Increase spay/neuter awareness and compliance, thereby reducing the number of unwanted litters born, and eliminating the need for those animals to require future housing in area animal shelters.
- 2. Provide affordable veterinary care to the public. There is a significant need for affordable medical care for companion animals. Often times the public is forced to surrender their pet to the shelter, or have him/her euthanized because they cannot afford medical care even more so given the current economic status. Our programs are geared to help provide the services and resources necessary to keep the pet in the home with his/her owner
- 3. Educate public on the basic elements of responsible pet care and ownership. We will meet face-to-face with citizens to provide them with the tools they need to provide their animals with the most appropriate are. Our education program will also be centered around feral and free roaming cat initiatives, providing alternative solutions to current practice of trap, and euthanize.

Detail specific methods you will use to achieve these objectives.

No More Homeless Pets KC will be partnering with Entercom Radio in January 2011 to market the programs and services we offer. We will also have an education officer in the field five days a week, to carry out face-to-face marketing and awareness. Our officer will be cultivating relationships in the community to gain support of the program's fundamental goals, as well as to help raise donations for necessary supplies to carry out the program.

No More Homeless Pets KC will also provide volume transport services for communities, neighborhoods, or organizations for which transportation is a challenge.

Our facility has the capacity to perform 80+ spay/neuter services per day, and our doctor's can see 16+ appointments per day. The board of No More Homeless Pets KC, our staff, and our volunteers are all committed to doing what is necessary to create a more responsible and humane community for the animals and citizens in the Kansas City Metro.

We also hope to work with the Jackson County Community Development offices to help raise awareness and advertise for program specials offered throughout the year.

#### Evaluation

The HERO Program is budgeted to provide spay/neuter services to 3,292 animals in 2011

Our affordable veterinary wellness clinic is budgeted to serve over 3,800 pets in 2011

Meet with the leaders of local five animal control agencies to educate them on the HERO program and gain their support of the program.

Present TNR (Trap, Neuter, Return) to city council once a quarter

Develop a core group of volunteers to provide support to the HERO program

Use social media to raise awareness to the program. Post appeals and stories regarding the program on Facebook three times a week.
