SIDEWALK AND PEDESTRIAN LICENSE

WHEREAS, Grantor is the owner of the real property described in Exhibit A attached hereto and incorporated herein by reference and as depicted on the drawing attached hereto as Exhibit B ("Sidewalk and Pedestrian License"); and

WHEREAS, Grantee desires to provide pedestrian access to a Kansas City Area Transportation Authority (KCATA) Troost Avenue Bus Rapid Transit Station as depicted on the site layout attached as Exhibit C (site layout) or similar Transit Station; and

WHEREAS, Grantor has agreed to grant a Sidewalk and Pedestrian License to Grantee for the placement, location, maintenance and use of a sidewalk upon the terms and conditions herein set forth.

Now, therefore, in consideration of the sum of One Dollar (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are herewith acknowledged by Grantor, Grantor does hereby grant, convey, release and remise unto Grantee a Sidewalk and Pedestrian License over, under, along and across the real estate described in Exhibit A; provided, however, that the license shall be nonrevocable for as long as the sidewalk and KCATA Troost Avenue Bus Rapid Transit Station as depicted on Exhibit C or similar Transit Station are in place. Grantor acknowledges that Grantor may not revoke the easement for as long as the sidewalk and KCATA Transit Station are in place, and Grantee acknowledges by its acceptance hereof that this license is being granted solely for the purpose of pedestrian use and to provide access to the KCATA Transit Station.

KCATA shall indemnify and hold County harmless from any and all claims, liabilities, damages, and costs (including reasonable attorney's fees directly related thereto) arising out of the construction and operation of the Transit Station, if and to the extent caused by the negligence or misconduct of KCATA.
