THIRD ADDENDUM TO CONSULTING AGREEMENT

THIS THIRD ADDENDUM, made and entered into this ______ day of _______, 2013, by and between JACKSON COUNTY, MISSOURI, hereinafter called "the County", and TUSA CONSULTING SERVICES, 75757 Highway 1082, Covington, LA, hereinafter called "Consultant."

WHEREAS, Consultant and County entered into a Consulting Agreement dated May 5, 2011, whereunder Consultant agreed to provide consulting services and assistance to the County in analyzing viable options for compliance with the FCC conversion mandate, at a cost to the County not to exceed \$38,250.00; and,

WHEREAS, the Consulting Agreement was amended pursuant to the First Addendum to Consulting Agreement, dated February 29, 2012, at an additional cost to the County not to exceed \$102,600.00 and was extended to December 31, 2013, pursuant to the Second Addendum; and,

WHEREAS, the parties now desire to increase the scope of the services to be provided by Consultant, at an increased cost; and,

WHEREAS, by Resolution 18290, dated October 28, 2013, the County Legislature has authorized this Third Addendum to the Consulting Agreement with Consultant to include relocation of the County's Public Safety Answer Point and dispatch equipment to the new Sheriff's Headquarters located at 4001 NE Lakewood Way, Lee's Summit, MO, as is more fully described in Consultant's proposal attached hereto as Exhibit A, and incorporated herein by reference.

MARY JO SPINO COUNTY CLERK NOW, THEREFORE, in consideration of the foregoing and the terms and provisions herein contained, County and Consultant respectively agree with each other as follows:

- 1. Except as expressly provided herein, all provisions of the Consulting Agreement, dated May 16, 2011, the First Addendum dated February 29, 2012, and the Second Addendum dated May 10, 2013, between Consultant and County shall remain in full force and effect.
- 2. The Scope of Services provided by Consultant shall be amended to include those services described in the attached Exhibit A.
- 3. The maximum sum to be paid by County to Consultant shall be increased by the amount of \$17,280.00, for a maximum total of \$158,130.00.
- 4. Consultant shall continue to bear all the expenses of its work under this Agreement.
- 5. This Third Addendum, together with the Consulting Agreement dated May 16, 2011, the First Addendum dated February 29, 2012, and the Second Addendum, dated May 10, 2013, incorporates the entire understanding and agreement of the parties.


