AN ORDINANCE transferring \$17,215.00 within and appropriating \$97,552.00 from the fund balance of the 2013 Anti-Drug Sales Tax Fund in acceptance of the State of Missouri JAG grant for use by the Jackson County Drug Task Force.

ORDINANCE NO. 4589, November 18, 2013

WHEREAS, the Jackson County Drug Task Force has received a Justice Assistance Grant (JAG) from the State of Missouri Department of Public Safety in the amount of \$97,552.00; and,

WHEREAS, the grant proceeds will be used to partially fund one criminalist forensic chemist, one full-time detective, and the lease of four vehicles; and,

WHEREAS, the grant is subject to a local match in the amount of \$17,215.00; and,

WHEREAS, a transfer and appropriation are necessary to place the grant and matching funds in the proper spending accounts; and,

WHEREAS, the County Executive recommends said transfer and appropriation; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the


