ADDENDUM TO AGREEMENT (Term and Supply Contract for Drug Court Program)

THIS ADDENDUM TO AGREEMENT, by and between JACKSON COUNTY, MISSOURI, hereinafter referred to as "the County," and HEARTLAND CENTER FOR BEHAVIORAL CHANGE d/b/a/ KANSAS CITY COMMUNITY CENTER, 1730 Prospect, Kansas City, MO 64127, a Missouri not-for-profit corporation, hereinafter referred to as "Organization," is made and entered into this 25 day of ________, 2014.

WITNESSETH:

WHEREAS, by Resolution 16986, dated August 10, 2009, the County and Organization did enter into an agreement whereby Organization agreed to provide substance abuse and/or other counseling services for the County's Drug Court Program, under the terms and conditions of Request for Proposals No. 14-09; and,

WHEREAS, new requirements set forth by the Office of State Courts Administrator will require a revision to the scope of services for outpatient substance abuse treatment; and,


WHEREAS, a six-month extension to the existing term and supply Agreement is necessary to allow the Prosecuting Attorney's Office sufficient time to revise the scope of services and to prevent a disruption of services to clients of the Drug Court; and,

WHEREAS, the Director of Finance and Purchasing recommends this extension to the Agreement with Organization; and,

WHEREAS, by Resolution 18540, dated June 9, 2014, the County Legislature has authorized the Director of Finance and Purchasing to enter into this Addendum to Agreement;

NOW THEREFORE, in consideration of the mutual covenants and promises herein contained, County and Organization do hereby additionally agree as follow:

1. Except as hereinafter specifically modified, all of the terms of the prior



Agreement between the parties dated September 25, 2009, shall remain in full force and effect and the terms and conditions thereof are incorporated herein by reference.

- 3. This Addendum to Agreement shall be effective as of August 30, 2014, and shall extend, with the original Agreement, through February 28, 2015.
- 4. This Addendum, together with the Agreement dated September 25, 2009, incorporates the entire understanding and agreement of the parties.
