## FIRST ADDENDUM TO COOPERATIVE AGREEMENT

THIS FIRST ADDENDUM made this 23 day of 2014, by and between JACKSON COUNTY, MISSOURI, hereinafter called "County" and SALVATION ARMY - LINWOOD CENTER SUPPORTIVE HOUSING, 101 W. LINWOOD BLVD., KANSAS CITY, MO 64111, hereinafter called "Salvation Army."

## WITNESSETH:

WHEREAS, Salvation Army and County entered into a Cooperative Agreement dated April 22, 2014, whereunder County will provide funding to be used for homelessness assistance through this Housing Resources Commission (HRC); and,

WHEREAS, Salvation Army was awarded a grant in the amount of \$10,000.00 by the HRC, as authorized by Resolution 18365, dated January 13, 2014; and,

WHEREAS, Salvation Army submitted a request to the HRC to utilize its \$10,000.00 with services provided within the first two quarters of 2014 because of a delay in funding the Salvation Army receives from Housing and Urban Development (HUD); and,

WHEREAS, the HRC voted at its meeting June 19, 2014, to recommend this Addendum to Cooperative Agreement; and,

WHEREAS, the execution of this addendum is authorized by Resolution 18555, dated June 23, 2014;

NOW, THEREFORE, in consideration of the foregoing and the terms and provisions herein contained, County and Salvation Army respectively agree with each other as follows:

- Except as expressly provided herein, all provisions of the Cooperative Agreement between Organization and County, dated April 22, 2014, shall remain in full force and effect.
- Paragraph 2., <u>Terms of Payment</u> of the Cooperative Agreement of April 22, 2014, is amended as follows:

"The County shall pay to Contractor a total amount not to exceed \$10,000.00 for the purpose of providing assistance to homeless persons in Jackson County, Missouri. One half of this sum, or \$5,000.00, shall be paid to Contractor for the periods ending March 31, 2014, and June 30, 2014, upon receipt of Contractor's invoice and supporting documentation, provided that Contractor has submitted to the County the report(s) required under Paragraph 3 and Paragraph 5 hereof. Each payment will be issued after Contractor has submitted the required invoices and supporting documentation for reimbursement. The County reserves the right to audit all invoices and to reject any invoice for good cause. The County retains the right to deduct from an invoice of Organization any overpayment made by the County on a prior invoice. The County retains the right to make invoice corrections/changes. The County will not reimburse sales tax expense."

- 3. This First Addendum to the Agreement, together with the Cooperative Agreement, dated April 22, 2014, shall be effective January 1, 2014 and shall extend until December 31, 2014.
- This First Addendum to Agreement, together with the Cooperative Agreement dated April 22, 2014, incorporates the entire understanding and agreement of the parties.
