Resolution 18751, dated 3/2/15, authorized payments in the amount of \$30,000.00 to each shelter representing the first one-half year of funding for the shelters. The Board met on June 16, 2015, to recommend the allocation of the remaining 2015 revenues, for equal distribution to the three shelters. The remaining revenues are \$50,248.00, to be distributed in equal amounts of \$16,749.33 to each of the three shelters: Hope House, Rose Brooks, and New House.
