

**FIRST ADDENDUM TO  
COOPERATIVE AGREEMENT**

THIS FIRST ADDENDUM made this 30<sup>th</sup> day of November, 2015, by and between JACKSON COUNTY, MISSOURI, hereinafter called "County" and MORNINGSTAR DEVELOPMENT COMPANY, 2411 E. 27<sup>th</sup> Street, Kansas City, MO 64127, hereinafter called "Organization."

**WITNESSETH:**

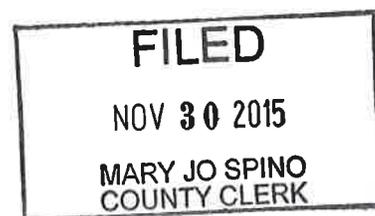
WHEREAS, Organization and County entered into a Cooperative Agreement dated July 7, 2015, whereunder County will provide funding to be used for a summer and after school program; and,

WHEREAS, it is necessary to revise the original budget presented by Organization by reallocating funds from its personal services to contractual services and supplies budget lines, as is more fully described in the Section C: 2015 Revised Program Budget page attached hereto as Exhibit A and incorporated herein by reference; and,

WHEREAS, the execution of this addendum is authorized by Resolution 18988, dated November 9, 2015;

NOW, THEREFORE, in consideration of the foregoing and the terms and provisions herein contained, County and Organization respectively agree with each other as follows:

1. Except as expressly provided herein, all provisions of the Cooperative Agreement between Organization and County, dated July 7, 2015, shall remain



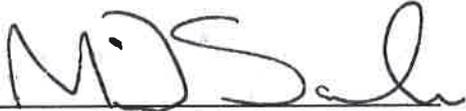
in full force and effect.

4. This First Addendum to Agreement, together with the Cooperative Agreement dated July 7, 2015, incorporates the entire understanding and agreement of the parties.

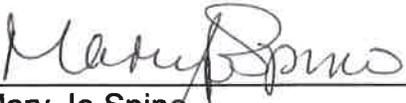
