REQUEST SUMMARY	The Jackson County Family Court Night Light Program is designed to address serious and potentially violent juvenile offenders who are either under pre-adjudication supervision, on probation, or re-entering the community from residential placement. The goals of the program are to hold youth accountable for their actions, reduce delinquent behavior, encourage sound social decision-making behavior and reduce illegal substance abuse. This program receives partial funding from Anti-Drug Sales Tax Funds to support its mission and goals. Under the program, a Family Court Services Juvenile Probation Officer and a uniformed Deputy Sheriff will make evening and late night supervision and surveillance checks on high-risk juvenile probationers. In exchange, the Family Court will reimburse the Sheriff's Office \$250.00 per month for the use of Sheriff's vehicles and provide an hourly off-duty pay rate of \$33.00 per hour, up to \$70,000.00 for 2016. This reimbursement will be paid through an inter-departmental billing. The attached agreement with the Family Court sets out the rights and obligations of each party (the Night Light Program manager and staff and the Sheriff's Office) for the Night Light Program. The Sheriff's Office is requesting authorization to execute the attached agreement.
