Charter County, hereinafter called "Jackson County" and Platte County, Missouri, a
County of the First Class of the State of Missouri, hereinafter called "Platte County,"

#### WITNESSETH:

WHEREAS, by Resolution 19003, dated November 16, 2015, the Jackson County Legislature did authorize the execution of an Agreement whereby the Jackson County Medical Examiner shall serve as the Medical Examiner for Platte County, for compensation payable to Jackson County, Missouri; and,

WHEREAS, the Jackson County and Platte County entered into an Agreement dated January 25, 2016, whereby, Diane Peterson, M.D., the duly appointed Medical Examiner of Jackson County, will serve as Platte County's Medical Examiner for the period of January 1, 2016, through December 31, 2016; and,

WHEREAS, pursuant to the Agreement of January 25, 2016, Platte County has agreed to pay to Jackson County a total sum of \$92,293.00 for the year 2016; and,

WHEREAS, the parties now desire to extend this Agreement for an additional two-month period, through March 1, 2017, at the same rate of compensation;

NOW THEREFORE, in consideration of the foregoing and the terms and provisions herein contained, the Jackson County and Platte County respectively promise, covenant, and agree with each other as follows:

- 1. Except as expressly provided herein, all provisions of the Agreement for Medical Examiner Services dated January 25, 2016, between Platte County and Jackson County shall remain in full force and effect.
- 2. This First Addendum shall be effective January 1, 2016, and shall extend until March 1, 2017.
- 3. Platte County shall pay to Jackson County an additional sum in the amount of \$7,691.00 for each month, for a total amount not to exceed \$15,382.00.
- 4. This First Addendum to Agreement, together with the Agreement dated January 25, 2016, incorporates the entire understanding and agreement of the parties.
