Re: Request for Transfer

The Jackson County Medical Examiner's Office (JCMEO) is requesting submission of the attached RLA for \$71,600 to cover a deficit in the JCMEO 2017 overtime budget.

The JCMEO Investigator staff works 48 hours per week to cover 24/7 operations. The Autopsy staff also works weekends in addition to the 40-hour workweek. We need funding for overtime to support services to Jackson, Cass, Clay, and Platte Counties. Prior to the 2014 budget, JCMEO has had adequate funds to cover these operations.
