FIRST ADDENDUM TO COOPERATIVE AGREEMENT

THIS FIRST ADDENDUM made this ______ day of _______,
2017, by and between JACKSON COUNTY, MISSOURI, hereinafter called "County"
and HEALING HOUSE, INC., 4420 ST. JOHN AVENUE, KANSAS CITY, MO 64123, a
not-for-profit organization, hereinafter called "Healing House."

WITNESSETH:

WHEREAS, Healing House and County entered into a Cooperative Agreement dated March 29, 2017, whereunder Healing House agreed to provide a drug treatment program, as authorized by Resolution 19396, dated February 27, 2017, at a cost to the County not to exceed \$135,000.00; and,

WHEREAS, Healing House and County now desire to enter into this Addendum to the Cooperative Agreement whereunder the County shall increase the funding allocation for these services for 2017 at an additional cost to the County not to exceed \$15,000.00; and,

WHEREAS, the execution of this addendum is authorized by Resolution 19504, dated June 5, 2017;

NOW, THEREFORE, in consideration of the foregoing and the terms and provisions herein contained, County and Healing House respectively agree with each other as follows:



- Except as expressly provided herein, all provisions of the Cooperative Agreement between Healing House and County, dated March 29, 2017, shall remain in full force and effect.
- This First Addendum to the Cooperative Agreement, together with the Cooperative Agreement, dated March 29, 2017, shall be effective until December 31, 2017.
- 3. The Cooperative Agreement of March 29, 2017, is amended by the addition of Exhibit C attached hereto, to be included with the Exhibit A attached to the Cooperative Agreement.
- 4. The maximum sum to be paid by County to Healing House shall be increased by the amount of \$15,000.00, for a maximum total of \$150,000.00, to be payable in six equal monthly payments of \$2,500.00 each.
- 5. This First Addendum to the Cooperative Agreement, together with the Cooperative Agreement dated March 29, 2017, incorporates the entire understanding and agreement of the parties.
