REQUEST SUMMARY	Accept and appropriate \$15,000.00 from the Undesignated Fund Balance of the Grant Fund and authorize the County Executive to execute an agreement with the Missouri Department of Highway and Transportation commission in acceptance of the grand awarded to the Sheriff's Office.  The Grant is awarded in the amount of \$15,000.00 and requires no matching funds, for July 1, 2017 through December 1, 2018 The term of the agreement dated August 1, 2017 states July 2017 through December 2018.  The goal of this enforcement is to create safer roadways in Jackson County, Missouri, with a focus on distracted and dangerous driving in work zones. The overall impact sought through this initiative is to reduce the danger to highway workers, while enforcing reduced speed work zones, and alert motorist of the presence of work zones in the night hours. Over the past several years, there has been a significant increase in night time hour work zones, due to lighter traffic flow, which creates an separate issue of visibility of the upcoming zone.  With the goal of mitigating the dangers to work crews, while altering and correcting the negative driving habits					

	of the public in these areas where failure to focus and use caution can be deadly, the Jackson County Sheriff's  Office requests these funds for the reimbursement of overtime utilized for the enforcement actions outlined above.
