COOPERATIVE AGREEMENT

AN AGREEMENT, made and entered into on this 28th day of Muguet , 2017 by and between JACKSON COUNTY, MISSOURI, hereinafter called "the County" and the SALT INITIATIVE, LLC, 3737 N. Kingshighway Blvd. Suite 110, St. Louis, MO 63115, hereinafter called "Organization."

WITNESSETH:

WHEREAS, the County and Organization desire to enter into an Agreement whereby Organization will provide Trauma Informed Care training, as authorized by Resolution 19534, dated July 24, 2017; and,

NOW THEREFORE, in consideration of the foregoing and the terms and provisions herein contained, the County and Organization respectively promise, covenant, and agree with each other as follows:

- 1. <u>Services To Be Provided</u>. Organization shall provide Trauma Informed Care training to COMBAT-funded agencies, as is more fully set out in the program proposal attached hereto as Exhibit A and incorporated herein by reference.
- 2. <u>Independent Contractor</u>. Organization shall work as an independent contractor and not as an employee of the County. Organization shall be subject to the direction of the County only as to the result to be accomplished and not as to the means and methods for accomplishing the result. Organization shall report all earnings received hereunder as gross income, and be responsible for its own Federal, State, and City withholding taxes and all other taxes, and operate its business independent of the business of the County, except as required by this Agreement.
 - 3. <u>Terms of Payment</u>. The County agrees to pay an amount not to exceed

Organization shall be paid at a rate of \$1,250.00 for each training session, upon receipt of Organizations invoice.

- 4. <u>Expenses</u>. Organization shall be responsible for all of its expenses incurred in the course of its work under this Agreement.
- 5. <u>Conflict of Interest</u>. Organization warrants that no officer or employee of the County, whether elected or appointed, shall in any manner whatsoever be interested in or receive any benefit from the profits or emoluments of this contract.
- 6. <u>Duration</u>. This Agreement shall be effective August 15, 2017, and terminate on October 15, 2017, or upon the County's receipt of the final report and accounting.
- 7. <u>Severability</u>. If any covenant or other provision of this Agreement is invalid, or incapable of being enforced, by reasons of any rule of law or public policy, all other conditions and provisions of this Agreement shall nevertheless remain in full force and effect and no covenant or provision shall be deemed dependent upon any other covenant or provision unless so expressed herein.
- 8. <u>Incorporation</u>. This Agreement incorporates the entire understanding and agreement of the parties.
