BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Counselor be and hereby is authorized to settle the claims of Shanquilla Wiggins, in the case styled Shanquilla Wiggins v. Jackson County, Missouri, et al, No. 1616-CV21267, by the total payment of \$150,000.00, in full, final and complete release of all of the claims against the County and all of its employees, officers, agents, and servants, as to any

damages incurred; and,

BE IT FURTHER RESOLVED that the County Counselor be and hereby is authorized to execute any and all documents necessary to effect this settlement; and,

BE IT FURTHER RESOLVED that the Chief Financial Officer be and hereby is authorized to issue a check or checks in an amount totaling \$150,000.00 in full and complete settlement of this claim, payable to Shanquilla Wiggins and/or her attorney, Robert Kinsman, pursuant to the specific direction of the County Counselor.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
