REQUEST SUMMARY	This resolution authorizes the County Executive, on behalf of the Jackson County Prosecutor, to enter into the third addendum to the agreement with Twelfth Street Heritage Development Corporation for the Employment Barriers Program, which was previously bid on RFP 17-16 and 12 th Street was the awardee of the contract. This employment contract with 12 th Street Heritage provides direct employment services for ex-felons, court involved or "at-risk" adults along with personal development and access to resources (i.e. counseling, heath care, skill building, etc.). Based on the success of the program, the Prosecutor's Office is looking to continue referral of clients for services through the term of this agreement (December 31, 2018), at an additional cost to the County not to exceed \$50,000.00.
