In 2009 the developer and the County exchanged two small parcels of park property needed by the developer to put in access roads on the development. The exchange followed the 6(f) conversion protocol for land purchased with Land & Water Conservation funds and Jackson County was given authorization to proceed with the property swap. The replacement property the County received in exchange was previously part of a larger development tract which carried with it a Declaration of Easements, Covenants and Conditions governing the development of the land. The County is listed as the owner of the two small replacement parcels that were included in the Declaration. The undeveloped portion of Trinity Woods is now being purchased by Lane4 Property Group. They wish to amend the Declaration prior to the purchase. In order to amend the Declaration all owners of property governed by the old Declaration must sign the Amendment of the Declaration. Lane4 is requesting that Jackson County sign the Amended Declaration. Signing the declaration will have no impact on the usability of the land owned by the County.
