- The sum to be paid by County to Contractor for 2018 shall be the amount of 3. \$50,000.00, for a maximum grand total of \$236,200.00.
- This THIRD Addendum to Agreement, together with the Agreement dated 4. June 21, 2016, the First Addendum dated March 29, 2017, and the Second Addendum to dated November 1, 2017 incorporates the entire understanding and agreement of the parties.
