	Exhibit A indicates the outside agencies and funding levels as recommended. These recommendations have been reviewed and approved by the Jackson County Drug Commission for 2018 fiscal year.					
	Background: The Anti-Drug Tax Fund authorizes the County to execute agreements and contracted services for the purpose of providing substance abuse treatment, prevention, grant match and other anti-drug initiatives in the community.					
	Exhibit A indicates the outside agencies that the Jackson County Drug Commission is recommending funding in 2018 to provide substance abuse treatment services in Jackson County. These recommendations are based upon renewals of funding for the proposals submitted in response by community providers. Funding recommendations were presented to the Jackson County Drug Commission on April 13, 2018, with the recommendation that the funding in Exhibit A be presented to the Jackson County Legislature.
