(Block 2 Block Program)

THIS AGREEMENT, made and entered into on this Znd day of July 2018, by and between JACKSON COUNTY, MISSOURI, hereinafter called the "County" and AD HOC GROUP AGAINST CRIME, 2701 E. 31st Street, Kansas City, Missouri 64128, hereinafter called "Ad Hoc."

WITNESSETH:

WHEREAS, Ad Hoc has agreed to provide a community outreach project in Jackson County, Missouri, in accordance with the terms, conditions, and covenants as set forth in this Agreement; and,

WHEREAS, this Agreement is authorized by Resolution 19871, dated May 21, 2018; and,

WHEREAS, Ad Hoc and County have agreed to be bound by the provisions hereof, NOW THEREFORE, in consideration of the foregoing and the terms and provisions herein contained, County and Ad Hoc respectively promise, covenant, and agree with each other as follows:

- 1. Ad Hoc shall fulfill its contractual obligations by providing the Block 2 Block community outreach program, as is more fully described in Ad Hoc's proposal, attached hereto and incorporated herein as Exhibit A.
- 2. Ad Hoc shall work as an independent contractor and not as an employee of County. Ad Hoc shall be subject to the direction of County only as to the result to be accomplished and not as to the means and methods for accomplishing the result. Ad Hoc shall report all earnings received hereunder as gross income, and be responsible for its



own Federal, State and City withholding taxes and all other taxes, and operate its business independent of the business of County except as required by this Agreement.

- 3. County shall pay Ad Hoc for services rendered under this Agreement in a total amount not to exceed \$3,777.00, in two payments not to exceed \$1,888.50, in accordance with the budget submitted by Ad Hoc, attached hereto as Exhibit B. Upon the execution of this agreement and receipt of Ad Hoc's invoice, the County shall make an initial payment to Ad Hoc in the amount of \$1,888.50. On or after December 31, 2018, Ad Hoc shall invoice the County for a second payment, providing documents and/or the evidence showing the initial payment was used for expenses in accordance with Exhibit B. County shall then make a second payment in an amount, equal to the agreement of the first payment properly expensed not to exceed \$1,888.50. At the conclusion of the program, Ad Hoc shall provide final report, including documentation of expenses. Final payment to Ad Hoc, or a return of any unexpended funds to the County, shall be made thereafter.
- 4. The initial term of this Agreement shall be effective as of July 1, 2018, and shall extend until June 30, 2019. Upon the agreement of both parties, this Agreement may be renewed for an additional twelve-month term.
- 5. Ad Hoc or County may terminate this Agreement by giving thirty days written notice to the other party. Termination of this Agreement shall not constitute a waiver of the rights or obligations which County or Ad Hoc may be entitled to receive or be obligated to perform under this Agreement. Should this Agreement terminate, all books, brochures, fliers, lists, and all other County materials must be delivered and returned by Ad Hoc to County within three days of the demand of County.

- 6. Ad Hoc promises, covenants, and agrees to keep all matters, materials, and information obtained from the County and all of Ad Hoc's investigation efforts and results relating to the herein referenced services confidential until such time that the County instructs Ad Hoc otherwise.
- Timely performance of all duties provided herein is of the essence of this
 Agreement.
- 8. Ad Hoc promises, covenants, and agrees to faithfully observe and perform all of the terms, provisions and requirements of this Agreement, and Ad Hoc's failure to so shall constitute a breach of this Agreement, and in such event, Ad Hoc consents and agrees as follows:
- (1) The County may without prior notice to Ad Hoc immediately terminate this Agreement; and,
- (2) The County shall be entitled to petition and receive from any Court a temporary and/or permanent injunction against Ad Hoc; and,
- (3) The County shall be entitled to collect from Ad Hoc all costs incurred by County as a result of said breach including reasonable attorney's fees, reasonable accountant's fees, investigation expenses, court costs and sheriff's mileage and service fees without limitation by enumeration and any other expenses incurred by the County in connection herewith.
- 9. Ad Hoc promises, covenants, and agrees, in addition to all other provisions herein, that during the term of this Agreement, it shall not assign any portion or the whole of this Agreement without the prior written consent of County.
 - 10. Pursuant to §285.530.1, RSMo, Ad Hoc assures that it does not knowingly

employ, hire for employment, or continue to employ an unauthorized alien to perform work within the State of Missouri and/or Jackson County, and shall affirm, by sworn affidavit and provision of documentation, its enrollment and participation in a federal work authorization program with respect to the employees working in connection with the contracted services. Further, Ad Hoc shall sign an affidavit, attached hereto and incorporated herein as Exhibit C, affirming that it does not knowingly employ any person who is an unauthorized alien in connection with the contracted services.

- 11. If any covenant or other provision of this Agreement is invalid or incapable of being enforced by reason of any rule of law or public policy, all other conditions and provisions of this Agreement shall nevertheless remain in full force and effect and no covenant or provision shall be deemed dependent upon any other covenant or provision unless so expressed herein.
- 12. This Agreement incorporates the entire understanding and agreement of the parties.

Block2Block Scope of Service/Deliverables

Block2Block (B2B) is a community outreach project seeking to promote economic, social, and environmental well-being, through building relationships within targeted blocks of the community. Using a place-based approach, the initial focus will be targeted blocks within .1 square miles of Prospect to Kensington, 31st to Linwood. B2B initiated its efforts in the area in May of 2017 and has continued with positive outcomes. The first phase, which will continue, consists of bi-weekly neighborhood walks to establish a welcoming community presence, through consistent face-to-face community interaction. B2B will also work to establish individual B2B member-to-community relationships, by hosting one-onon conversations with community representatives who are interested in supporting efforts of economic, social, and environmental promotion. Efforts for community improvement and promotion will be shaped and implemented through the input and help of aforementioned representatives. Community block gatherings will be hosted to impact the promotion of positive social engagement and create community to local organization partnerships. These gatherings will also host job opening information and recruitment agents to increase economic support and training. Community representatives and B2B will work to form neighborhood accountability groups. B2B will also facilitate in local promotion of vocational training access. B2B views targeted economic opportunity and development as a key contributor to the effect of increased environmental safety and positive social change. Integral to capturing community progress, B2B will work to development measurement tools utilizing the Social Network Analysis model. B2B uses Ad Hoc as its fiscal agent.

WORK AUTHORIZATION AFFIDAVIT
