**AN ORDINANCE** repealing Ordinance 5111, dated June 25, 2018, and transferring \$181,994.00 within and appropriating \$307,920.00 from the undesignated fund balance of the 2018 Anti-Drug Sales Tax Fund in acceptance of the DART Grant awarded by the Missouri Department of Public Safety.

WHEREAS, the Missouri Department of Public Safety has awarded a grant in the amount of \$125,925.90 to the Prosecuting Attorney's Office for its Drug Abuse Response Team (DART) program; and,

WHEREAS, the grant is subject to a local match; and,

WHEREAS, an appropriation is necessary to place the grant and matching funds in the proper spending accounts; and,

WHEREAS, Ordinance 5111, dated June 25, 2018, which previously appropriated these grant proceeds, contained an error in an account code and should be repealed; now therefore,
