This lease was assigned to Jackson County when it acquired the Rock Island Rail Corridor from the Union Pacific in 2016. The lease payment from Billy Goat Industries is \$5,000 per year. Pursuant to the Maintenance and Management Agreement with the Kansas City Area Transportation Authority (KCATA), RIRCA is requesting that these funds be appropriated for the maintenance of the Rock Island Rail Corridor.
